#### **SUMMARY**

Modifies terminology in domestic relations proceedings regarding custody of and parenting time with children.

- 10 Be It Enacted by the People of the State of Oregon:
- 11 <u>SECTION 1.</u> Section 2 of this 2019 Act is added to and made a part 12 of ORS chapter 107.
- 13 **SECTION 2.** As used in this chapter:
- 14 (1)(a) "Custody" means the legal relationship in which one person
- 15 is given decision-making responsibility concerning the child, including,
- but not limited to, the child's residence, education, health care and
- 17 religious training.

- (b) "Custody" does not mean parenting time.
- 19 (2) "Joint custody" means an agreement, approved by the court, by
- 20 which parents share rights and responsibilities for major decisions
- 21 concerning the child, including, but not limited to, the child's resi-

- 1 dence, education, health care and religious training.
- 2 (3) "Parenting time" means the time during which a person is ex-
- 3 ercising supervision and physical care of the child pursuant to an or-
- 4 der or judgment for custody or parenting time under this chapter or
- 5 ORS chapter 108.
- 6 **SECTION 3.** ORS 107.169 is amended to read:
- 7 107.169. [(1) As used in this chapter, "joint custody" means an arrangement
- 8 by which parents share rights and responsibilities for major decisions con-
- 9 cerning the child, including, but not limited to, the child's residence, educa-
- 10 tion, health care and religious training.]
- 11 (1) An order [providing for] approving a joint custody agreement may:
- 12 **(a)** Specify one home as the primary residence of the child; and 13 [designate]
- 14 (b) Allocate decision-making responsibilities between the parents,
- 15 including designation of one parent to have sole [power] authority to
- 16 make decisions about specific matters while both parents retain equal rights
- 17 and responsibilities for other decisions.
- 18 (2) The existence of an order [of] approving a joint custody agreement
- 19 shall not, by itself[,]:
- 20 (a) Determine the responsibility of each parent to provide for the support
- 21 of the child[.]; or
- 22 (b) Allocate parenting time equally between the parents.
- 23 (3) The court shall not [order] approve a joint custody agreement, un-
- 24 less both parents agree to the terms and conditions of the [order]
- 25 agreement.
- 26 (4) When parents have agreed to joint custody in an order or a judgment,
- 27 the court may not overrule that agreement by ordering [sole] custody to one
- 28 parent.
- 29 (5) Modification of [a] an order approving a joint custody [order]
- 30 **agreement** shall require **a** showing of changed circumstances and a showing
- 31 that the modification is in the best interests of the child such as would

- 1 support modification of a [sole] custody order. Inability or unwillingness to
- 2 continue to cooperate shall constitute a change of circumstances sufficient
- 3 to modify [a] an order approving a joint custody [order] agreement.
- 4 (6)(a) The inability of a parent to comply with the terms and conditions
- 5 of [a] an order approving a joint custody [order] agreement due to the
- 6 parent's temporary absence does not constitute a change of circumstances if
- 7 the parent's temporary absence is caused by the parent being:
- 8 (A) Called into state active duty as defined in the Oregon Code of Mili-
- 9 tary Justice; or
- 10 (B) Called into active federal service under Title 10 of the United States
- 11 Code as a member of the Oregon National Guard.
- 12 (b) As used in this subsection, "temporary absence" means a period not
- 13 exceeding 30 consecutive months.
- 14 (7) Solely for the purposes of all state and federal statutes that re-
- 15 quire a designation or determination of custody or a custodian, an
- order approving a joint custody agreement shall designate the parent
- 17 who is allocated the majority of decision-making responsibilities. This
- 18 designation does not affect parents' rights and responsibilities under
- 19 the order approving the joint custody agreement.
- SECTION 4. ORS 107.036 is amended to read:
- 21 107.036. (1) The doctrines of fault and of in pari delicto are abolished in
- 22 suits for the annulment or dissolution of a marriage or for separation.
- 23 (2) The court shall not receive evidence of specific acts of misconduct,
- 24 excepting where [child] custody of, or parenting time with, a child is an
- 25 issue and such evidence is relevant to that issue, or excepting at a hearing
- 26 when the court finds such evidence necessary to prove irreconcilable differ-
- 27 ences.
- 28 (3) In dividing, awarding and distributing the real and personal property
- 29 (or both) of the parties (or either of them) between the parties, or in making
- 30 such property or any of it subject to a trust, and in fixing the amount and
- 31 duration of the contribution one party is to make to the support of the other,

- 1 the court shall not consider the fault, if any, of either of the parties in
- 2 causing grounds for the annulment or dissolution of the marriage or for
- 3 separation.
- 4 (4) Where satisfactory proof of grounds for the annulment or dissolution
- 5 of a marriage or for separation has been made, the court shall render a
- 6 judgment for the annulment or dissolution of the marriage or for separation.
- 7 A judgment of separation shall state the duration of the separation.
- 8 **SECTION 5.** ORS 107.095 is amended to read:
- 9 107.095. (1) After the commencement of a suit for marital annulment,
- 10 dissolution or separation and until a general judgment therein, the court
- 11 may provide as follows:
- 12 (a) That a party pay to the other party such amount of money as may be
- 13 necessary to enable the other party to prosecute or defend the suit, including
- 14 costs of expert witnesses, and also such amount of money to the other party
- as may be necessary to support and maintain the other party.
- (b) For the care, custody, support and maintenance, by one party or
- 17 jointly, of the minor children as described in ORS 107.105 (1)(a) and for the
- parenting time rights of each parent as described in ORS 107.105 (1)(b) [of
- 19 the parent not having custody of such children].
- 20 (c) For the restraint of a party from molesting or interfering in any
- 21 manner with the other party or the minor children.
- 22 (d) That if minor children reside in the family home and the court con-
- 23 siders it necessary for their best interest to do so, the court may require ei-
- 24 ther party to move out of the home for such period of time and under such
- 25 conditions as the court may determine, whether the home is rented, owned
- 26 or being purchased by one party or both parties.
- 27 (e) Restraining and enjoining either party or both from encumbering or
- 28 disposing of any of the real or personal property of either or both of the
- 29 parties, except as ordered by the court.
- 30 (f) For the temporary use, possession and control of the real or personal
- 31 property of the parties or either of them and the payment of installment liens

1 and encumbrances thereon.

- (g) That even if no minor children reside in the family home, the court may require one party to move out of the home for such period of time and under such conditions as the court determines, whether the home is rented, owned or being purchased by one party or both parties if that party assaults or threatens to assault the other.
- (2) A limited judgment under ORS chapter 18 may be entered in an action for dissolution or annulment of a marriage providing for a support award, as defined by ORS 18.005, or other money award, as defined by ORS 18.005.

  Notwithstanding ORS 19.255, a limited judgment entered under this subsection may not be appealed. Any decision of the court in a limited judgment subject to this subsection may be appealed as otherwise provided by law upon entry of a general judgment.
  - (3) The court shall not require an undertaking in case of the issuance of an order under subsection (1)(c), (d), (e), (f) or (g) of this section.
- (4) In a suit for annulment or dissolution of marriage or for separation, 16 wherein the parties are copetitioners or the respondent is found by the court 17 to be in default or the respondent having appeared has waived further ap-18 pearance or the parties stipulate to the entry of a judgment, the court may, 19 when the cause is otherwise ready for hearing on the merits, in lieu of such 20 21 hearing, enter a judgment of annulment or dissolution or for separation based upon a current affidavit or declaration under penalty of perjury in the 22 form required by ORCP 1 E, executed by the petitioner or copetitioners, 23 setting forth a prima facie case, and covering such additional matters as the 24 court may require. If custody of, or parenting time with, minor children 25 is involved, then the affidavit or declaration under penalty of perjury must 26 also include the name of the party with whom the children currently reside 27 and the length of time they have so resided. 28
- 29 (5) When a court orders relief under subsection (1)(c) or (d) of this sec-30 tion, the court may include in its order an expiration date for the order to 31 allow entry of the order into the Law Enforcement Data System and the

- 2 Department of Justice as provided in ORS 107.720. If the person being re-
- 3 strained was provided notice and an opportunity to be heard, the court shall
- 4 also include in the order, when appropriate, terms and findings sufficient
- 5 under 18 U.S.C. 922 (d)(8) or (g)(8) to affect the person's ability to possess
- 6 firearms and ammunition or engage in activities involving firearms.
- 7 **SECTION 6.** ORS 107.097 is amended to read:
- 8 107.097. (1) Except as otherwise provided in subsection (3) of this section,
- 9 a court may not enter ex parte a temporary order under ORS 107.095, 109.103
- or 109.119 providing for the custody of, or parenting time with, a child.
- 11 (2)(a) A party may apply to a court for a temporary protective order of
- 12 restraint by filing with the court an affidavit or a declaration under penalty
- of perjury in the form required by ORCP 1 E, conforming to the requirements
- 14 of ORS 109.767.
- 15 (b) Upon receipt of an application under this subsection, the court may
- 16 issue a temporary protective order of restraint restraining and enjoining
- 17 each party from:
- 18 (A) Changing the child's usual place of residence;
- (B) Interfering with the present placement and daily schedule of the child;
- 20 (C) Hiding or secreting the child from the other party;
- 21 (D) Interfering with the other party's usual contact and parenting time
- 22 with the child;
- 23 (E) Leaving the state with the child without the written permission of the
- 24 other party or the permission of the court; or
- 25 (F) In any manner disturbing the current schedule and daily routine of
- 26 the child until custody or parenting time has been determined.
- 27 (c) A copy of the order and the supporting affidavit or declaration under
- 28 penalty of perjury must be served on the other party in the manner of service
- 29 of a summons under ORCP 7. The order must include the following state-
- 30 ment:

Notice: You may request a hearing on this order as long as it remains in effect by filing with the court a request for a hearing. In the request you must tell the court and the other party that you object to the order and specifically why you disagree with the representation of the status quo described in the order. In the request you must also inform the court of your telephone number or contact number and your current residence, mailing or contact address.

(3)(a) A court may enter ex parte a temporary order providing for the custody of, or parenting time with, a child if:

- (A) The party requesting an order is present in court and presents an affidavit or a declaration under penalty of perjury, alleging that the child is in immediate danger; and
- (B) The court finds, based on the facts presented in the party's testimony, the party's affidavit or declaration under penalty of perjury and the testimony of the other party, if the other party is present, that the child is in immediate danger.
- (b) The party requesting an order under this subsection shall provide the court with telephone numbers where the party can be reached at any time during the day and a contact address.
- (c) A copy of the order and the supporting affidavit or declaration under penalty of perjury must be served on the other party in the manner of service of a summons under ORCP 7. The order must include the following statement:

Notice: You may request a hearing on this order as long as it remains in effect by filing with the court a request for a hearing. In the request you must tell the court and the other party that you object to the order on the ground that the child was not in immediate danger at the time the order was issued. In the request you must also inform the court of your telephone number or contact number and your current residence, mailing or contact

- (4)(a) A party against whom an order is entered under subsection (2) or (3) of this section may request a hearing by filing with the court a hearing request described in subsection (2) or (3) of this section at any time while the order is in effect.
- (b) The court shall make reasonable efforts to hold a hearing within 14 days and shall hold a hearing no later than 21 days after receipt of the request for the hearing. The court shall notify each party of the time, date and place of the hearing.
- (c) An order issued under subsection (2) or (3) of this section remains in effect through the date of the hearing. If the party against whom the order was entered fails to appear at the hearing without good cause, the court shall continue the order in effect. If the party who obtained the order fails to appear at the hearing without good cause, the court shall vacate the order.
- 17 (d) The issue at a hearing to contest:
- (A) A temporary protective order of restraint is limited to a determination of the status quo at the time the order was issued. If the child's usual place of residence cannot be determined, the court may make any further order the court finds appropriate in the best interests of the child.
- (B) A temporary order for the custody of, or parenting time with, a child is limited to whether the child was in immediate danger at the time the order was issued.
- 25 (5) The State Court Administrator shall prescribe the content and form 26 of a request for a hearing described in subsections (2) and (3) of this section.
- 27 (6) As used in this section:
- 28 (a) "Child's usual place of residence" has the meaning given that term in 29 ORS 107.138.
- 30 (b) "Party's usual contact and parenting time," "present placement and daily schedule of the child" and "current schedule and daily routine of the

- 1 child" have the meanings given "parent's usual contact and parenting
- 2 time," "present placement and daily schedule of the child" and "current
- 3 schedule and daily routine of the child" in ORS 107.138.
- 4 **SECTION 7.** ORS 107.102 is amended to read:
- 5 107.102. (1) In any proceeding to establish or modify a judgment providing
- 6 for parenting time with a child, except for matters filed under ORS 107.700
- 7 to 107.735, there shall be developed and filed with the court a parenting plan
- 8 to be included in the judgment. A parenting plan may be either general or
- 9 detailed.
- 10 (2) A general parenting plan may include a general outline of how par-
- 11 ental responsibilities and parenting time will be shared and may allow the
- 12 parents to develop a more detailed agreement on an informal basis. However,
- 13 a general parenting plan must set forth the minimum amount of parenting
- 14 time and access [a noncustodial] each parent is entitled to have.
- 15 (3) A detailed parenting plan may include, but need not be limited to,
- 16 provisions relating to:
- 17 (a) Residential schedule;
- (b) Holiday, birthday and vacation planning;
- 19 (c) Weekends, including holidays, and school in-service days preceding or
- 20 following weekends;
- 21 (d) Any delegation of decision-making [and responsibility] by the parent
- 22 having decision-making responsibility to the parent exercising par-
- 23 enting time;
- 24 (e) Responsibilities of the parent exercising parenting time;
- 25 [(e)] (f) Information sharing and access;
- 26 [(f)] (g) Relocation of parents;
- [(g)] (h) Telephone access;
- [(h)] (i) Transportation; and
- 29 [(i)] (j) Methods for resolving disputes.
- 30 (4)(a) The court shall develop a detailed parenting plan when:
- 31 (A) So requested by either parent; or

- 1 (B) The parent or parents are unable to develop a parenting plan.
- 2 (b) In developing a parenting plan under this subsection, the court may 3 consider only the best interests of the child and the safety of the parties.
- 4 **SECTION 8.** ORS 107.105 is amended to read:

- 5 107.105. (1) Whenever the court renders a judgment of marital annulment, 6 dissolution or separation, the court may provide in the judgment:
  - (a) For the future care and custody, by one party or jointly, of all minor children of the parties born, adopted or conceived during the marriage and for minor children born to the parties prior to the marriage, as the court may deem just and proper under ORS 107.137. [The court may hold a hearing to decide the custody issue prior to any other issues.] When appropriate, the court shall recognize the value of close contact with both parents and encourage joint [parental] custody and joint responsibility for the welfare of the children.
- (b) For parenting time rights of the [parent not having custody of such 15 children] parents and for visitation rights pursuant to a petition filed under 16 ORS 109.119. When a parenting plan has been developed as required by ORS 17 107.102, the court shall review the parenting plan and, if approved, incorpo-18 rate the parenting plan into the court's final order. When incorporated into 19 a final order, the parenting plan is determinative of parenting time rights. 20 If the parents have been unable to develop a parenting plan or if either of 21 the parents requests the court to develop a detailed parenting plan, the court 22 shall develop the parenting plan in the best interest of the child, ensuring 23 [the noncustodial] each parent sufficient access to the child to provide for 24 appropriate quality parenting time and ensuring the safety of the parties, if 25 implicated. The court shall deny parenting time to a parent under this par-26 agraph if the court finds that the parent has been convicted of rape under 27 ORS 163.365 or 163.375 or other comparable law of another jurisdiction and 28 the rape resulted in the conception of the child. Otherwise, the court may 29 deny parenting time to [the noncustodial] a parent under this subsection only 30 if the court finds that parenting time would endanger the health or safety 31

1 of the child. In the case of a [noncustodial] parent who has a disability as defined by the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 et 2 seq.), the court may consider the [noncustodial] parent's disability in deter-3 mining parenting time only if the court finds that behaviors or limitations related to the [noncustodial] parent's disability are endangering or will likely 5 endanger the health, safety or welfare of the child. The court shall recognize 6 the value of close contact with both parents and encourage, when practica-7 ble, joint responsibility for the welfare of such children and extensive con-8 tact between the minor children of the divided marriage and the parties. If 9 the court awards parenting time to a [noncustodial] parent who has com-10 mitted abuse, other than being convicted for rape as described in this para-11 12 graph, the court shall make adequate provision for the safety of the child and the other parent in accordance with the provisions of ORS 107.718 (6). 13

- (c) For the support of the children of the marriage by the parties. In ordering child support, the formula established under ORS 25.275 shall apply. The court may at any time require an accounting from the [custodial] parent receiving child support with reference to the use of the money received as child support. The court is not required to order support for any minor child who has become self-supporting, emancipated or married or for any child who has ceased to attend school after becoming 18 years of age. A general judgment entered under this section may include an amount for support as requested in a petition filed under ORS 107.085 or under a motion for relief made pursuant to ORS 107.095 (1)(b) for which a limited judgment was not entered, payment of which commences no earlier than the date the petition or motion was served on the nonrequesting party, and the amount shall be considered a request for relief that has been decided by the general judgment for purposes of ORS 18.082 (3).
- 28 (d) For spousal support, an amount of money for a period of time as may 29 be just and equitable for one party to contribute to the other, in gross or in 30 installments or both. Unless otherwise expressly provided in the judgment 31 and except for any unpaid balance of previously ordered spousal support, li-

- 1 ability for the payment of spousal support shall terminate on the death of either party, and there shall be no liability for either the payment of spousal 2 support or for any payment in cash or property as a substitute for the pay-3 ment of spousal support after the death of either party. The court may approve an agreement for the entry of an order for the support of a party. A 5 general judgment entered under this section may include an amount for 6 support as requested in a petition filed under ORS 107.085 or under a motion 7 for relief made pursuant to ORS 107.095 (1)(b) for which a limited judgment 8 was not entered, payment of which commences no earlier than the date the 9 petition or motion was served on the nonrequesting party, and the amount 10 shall be considered a request for relief that has been decided by the general 11 12 judgment for purposes of ORS 18.082 (3). In making the spousal support order, the court shall designate one or more categories of spousal support and 13 shall make findings of the relevant factors in the decision. The court may 14 order: 15
- (A) Transitional spousal support as needed for a party to attain education 16 and training necessary to allow the party to prepare for reentry into the job market or for advancement therein. The factors to be considered by the court in awarding transitional spousal support include but are not limited to:
- (i) The duration of the marriage; 20

- (ii) A party's training and employment skills; 21
- (iii) A party's work experience; 22
- (iv) The financial needs and resources of each party; 23
- (v) The tax consequences to each party; 24
- (vi) A party's [custodial] parenting time and child support responsibil-25 ities; and 26
- (vii) Any other factors the court deems just and equitable. 27
- (B) Compensatory spousal support when there has been a significant fi-28 nancial or other contribution by one party to the education, training, voca-29 tional skills, career or earning capacity of the other party and when an order 30 31 for compensatory spousal support is otherwise just and equitable in all of the

- 1 circumstances. The factors to be considered by the court in awarding
- 2 compensatory spousal support include but are not limited to:
- 3 (i) The amount, duration and nature of the contribution;
- 4 (ii) The duration of the marriage;
- 5 (iii) The relative earning capacity of the parties;
- 6 (iv) The extent to which the marital estate has already benefited from the
- 7 contribution;
- 8 (v) The tax consequences to each party; and
- 9 (vi) Any other factors the court deems just and equitable.
- 10 (C) Spousal maintenance as a contribution by one spouse to the support
- of the other for either a specified or an indefinite period. The factors to be
- 12 considered by the court in awarding spousal maintenance include but are not
- 13 limited to:
- (i) The duration of the marriage;
- 15 (ii) The age of the parties;
- 16 (iii) The health of the parties, including their physical, mental and emo-
- 17 tional condition;
- (iv) The standard of living established during the marriage;
- 19 (v) The relative income and earning capacity of the parties, recognizing
- that the wage earner's continuing income may be a basis for support distinct
- 21 from the income that the supported spouse may receive from the distribution
- 22 of marital property;
- 23 (vi) A party's training and employment skills;
- 24 (vii) A party's work experience;
- 25 (viii) The financial needs and resources of each party;
- 26 (ix) The tax consequences to each party;
- 27 (x) A party's [custodial] parenting time and child support responsibil-
- 28 ities; and
- 29 (xi) Any other factors the court deems just and equitable.
- 30 (e) For the delivery to one party of such party's personal property in the
- 31 possession or control of the other at the time of the giving of the judgment.

- (f) For the division or other disposition between the parties of the real or personal property, or both, of either or both of the parties as may be just and proper in all the circumstances. In determining the division of property under this paragraph, the following apply:
- 5 (A) A retirement plan or pension or an interest therein shall be consid-6 ered as property.
- 7 (B) The court shall consider the contribution of a party as a homemaker 8 as a contribution to the acquisition of marital assets.
- 9 (C) Except as provided in subparagraph (D) of this paragraph, there is a 10 rebuttable presumption that both parties have contributed equally to the 11 acquisition of property during the marriage, whether such property is jointly 12 or separately held.
- (D)(i) Property acquired by gift to one party during the marriage and separately held by that party on a continuing basis from the time of receipt is not subject to a presumption of equal contribution under subparagraph (C) of this paragraph.
- (ii) For purposes of this subparagraph, "property acquired by gift" means property acquired by one party through gift, devise, bequest, operation of law, beneficiary designation or inheritance.
- (E) Subsequent to the filing of a petition for annulment or dissolution of marriage or separation, the rights of the parties in the marital assets shall be considered a species of co-ownership, and a transfer of marital assets under a judgment of annulment or dissolution of marriage or of separation entered on or after October 4, 1977, shall be considered a partitioning of jointly owned property.
- 26 (F) The court shall require full disclosure of all assets by the parties in 27 arriving at a just property division.
- (G) In arriving at a just and proper division of property, the court shall consider reasonable costs of sale of assets, taxes and any other costs reasonably anticipated by the parties.
- 31 (H)(i) If a party has been awarded spousal support in lieu of a share of

- property, the court shall so state on the record and shall order the obligor to provide for and maintain life insurance in an amount commensurate with the obligation and designating the obligee as beneficiary for the duration of the obligation.
  - (ii) The obligee or attorney of the obligee shall cause a certified copy of the judgment to be delivered to the life insurance company or companies.
  - (iii) If the obligee or the attorney of the obligee delivers a true copy of the judgment to the life insurance company or companies, identifying the policies involved and requesting such notification under this section, the company or companies shall notify the obligee, as beneficiary of the insurance policy, whenever the policyholder takes any action that will change the beneficiary or reduce the benefits of the policy. Either party may request notification by the insurer when premium payments have not been made. If the obligor is ordered to provide for and maintain life insurance, the obligor shall provide to the obligee a true copy of the policy. The obligor shall also provide to the obligee written notice of any action that will reduce the benefits or change the designation of the beneficiaries under the policy.
- 18 (g) For the creation of trusts as follows:

- (A) For the appointment of one or more trustees to hold, control and manage for the benefit of the children of the parties, of the marriage or otherwise such of the real or personal property of either or both of the parties, as the court may order to be allocated or appropriated to their support and welfare, and to collect, receive, expend, manage or invest any sum of money awarded for the support and welfare of minor children of the parties.
  - (B) For the appointment of one or more trustees to hold, manage and control such amount of money or such real or personal property of either or both of the parties, as may be set aside, allocated or appropriated for the support of a party.

The terms of child support and parenting time [(visitation)] are designed for the child's benefit and not the parents' benefit. You must pay support even if you are not receiving [visitation] parenting time. You must comply with [visitation] parenting time orders even if you are not receiving child support.

Violation of child support orders and [visitation] **parenting time** orders is punishable by fine, imprisonment or other penalties.

Publicly funded help is available to establish, enforce and modify child support orders. Paternity establishment services are also available. Contact your local district attorney or the Department of Justice at (503) 373-7300 for information.

Publicly funded help may be available to establish, enforce and modify [visitation] **parenting time** orders. Forms are available to enforce visitation orders. Contact the domestic relations court clerk or civil court clerk for information.

<sup>(2)</sup> The court or administrative law judge shall ensure the creation and filing of an order or judgment that complies with this section.

<sup>(3)</sup> This section does not apply to an action undertaken by the Division of Child Support of the Department of Justice or a district attorney under ORS 25.080.

- 1 (A) Is unmarried;
- 2 (B) Is 18 years of age or older and under 21 years of age;
- 3 (C) Is making satisfactory academic progress as defined by the school that
- 4 the child attends; and
- 5 (D) Has a course load that is no less than one-half of the load that is
- 6 determined by the school to constitute full-time enrollment.
- 7 (b) "Regularly scheduled break" means:
- 8 (A) A summer semester or term;
- 9 (B) A period of time not exceeding four months between graduation from
- 10 or completion of school and the beginning of the next regularly scheduled

- (c) Terminate a duty of support toward any minor child who has become self-supporting, emancipated or married;
- 30 (d) After service of notice on the child in the manner provided by law for 31 service of a summons, suspend future support for any child who has ceased

- 1 to be a child attending school as defined in ORS 107.108; and
- 2 (e) Set aside, alter or modify any portion of the judgment that provides
- 3 for a property award based on the enhanced earning capacity of a party that

- (E) Apportioned Veterans' benefits or Survivors' and Dependents' Educational Assistance under 38 U.S.C. chapter 35 paid to a child, or to a representative payee administering the funds for the child's use and benefit, as a result of the obligor's disability or retirement if the benefits:
  - (i) Were not previously considered in the child support order; or
- 6 (ii) Were considered in an action initiated before May 12, 2003.

- 7 (b) If the motion for modification is one made by the obligor to reduce or terminate support, and if the obligee opposes the motion, the court shall 8 not find a change in circumstances sufficient for reconsideration of support 9 provisions, if the motion is based upon a reduction of the obligor's financial 10 status resulting from the obligor's taking voluntary retirement, partial vol-11 12 untary retirement or any other voluntary reduction of income or self-imposed curtailment of earning capacity, if it is shown that such action of the obligor 13 was not taken in good faith but was for the primary purpose of avoiding the 14 support obligation. In any subsequent motion for modification, the court 15 shall deny the motion if the sole basis of the motion for modification is the 16 termination of voluntarily taken retirement benefits and the obligor previ-17 ously has been found not to have acted in good faith. 18
- 19 (c) The court shall consider the following factors in deciding whether the 20 actions of the obligor were not in "good faith":
