Children First was founded in 1991 to improve the lives of Oregon children by galvanizing community support and informing decision-makers about the solutions kids need. The Children First Board of Directors and staff support and appreciate our colleagues who work in policy arenas impacting Oregon children and families.

Invest in Oregon's Children.

Parents, advocates, and policymakers know that children's needs are as diverse as they are interconnected. Children need financially secure families to grow into successful adults. They require conditions that promote their educational achievement, from quality prenatal care to K-12 education. Children need a healthy, balanced foundation, mentally, physically, spiritually, and emotionally for future success. The absence of stable housing, adequate nutrition, academic opportunities, preventative health care, or mental health supports put all other aspects of child well-being at risk.

In order for every child in Oregon to thrive, all of the conditions that contribute to their success must be met. This means ensuring that children grow up in self-sufficient families, have regular access to physical, dental, and mental health services, and attend quality child care and schools. It also means removing the barriers preventing too many children of color, children with disabilities, children living in rural communities, and other disparately impacted children from reaching their full potential.

With the 2019 Children's Agenda and over 110 Children's Agenda partner organizations representing the wide range of policy areas impacting child well-being, we stand together to propose legislative solutions and investments that will allow us to provide a strong foundation for Oregon's future generation. We acknowledge that even if we agree on what our children and youth need, we also have to support the Oregon Legislature as it finds a mechanism to raise the revenue required to make the investments in children that will guarantee their future, and our future as a state.

There are many policy initiatives that should be enacted to ensure Oregon becomes a place where all children thrive.

Four concepts in the 2019 Children's Agenda are prioritized because of the beneficial impact on Oregon children, especially for those who have been historically underserved, including children of color and children experiencing disabilities. We urge the Legislature to act on solutions that eliminate disparities and create a level playing field for children.

All children need a safe, stable place to call home. Four of every 10 families in Oregon rent their homes and because of historic disparities in access to wealth and homeownership, people who rent their homes are more likely to be people of color. By **protecting people who rent their homes from unfair evictions and rent spikes**, we can prevent dangerous housing instability for families with children, and help kids remain stable in their classrooms and homes.

Our priorities also elevate two evidence-based programs to support our youngest Oregonians.

Universal home visiting for every newborn

would provide one to three visits beginning at three weeks of age for every newborn and more intensive family support services for all Oregon families who need them. Young children who experience barriers to opportunity due to poverty, race, disability, or geographic location can avoid poor outcomes through **access to high-quality early education**. Children without that access are 25% more likely to dropout of high school, 50% more likely to need special education intervention, and 60% less likely to attend college. Expanding access to quality preschool programs with an equity lens can help avoid those negative outcomes.

Oregon's foster youth need multiple layers of support from foster families, communities, and other caring adults. They also need the Independent Living Program (ILP) to help them build the skills to map out and implement their pathway to adulthood. **Expanding funding for the ILP services** to expand the ages served to 14 – 23 will help to ensure that more foster youth have the tools needed to become successful, self-sufficient adults.

Protect Families from Unfair Evictions, Economic Evictions

Prevent displacement and instability for children and their families by preventing unfair no-cause evictions and unlimited rent increases.

Expand Transition Services for Foster Youth

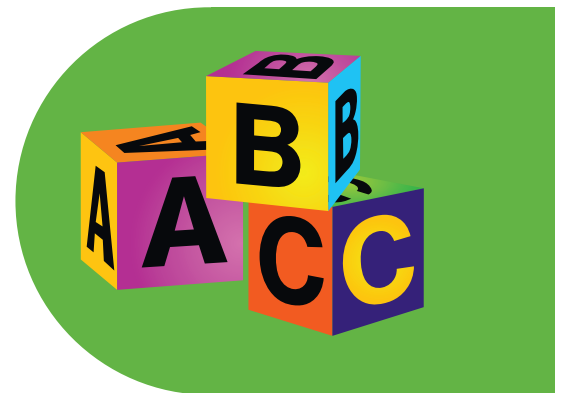

EDUCATION

Expand Access to Early Learning

Expand access to quality early learning programs for 10,000 children. A quality early learning system includes Preschool (Preschool Promise and Oregon PreKindergarten), an Early Childhood Equity Fund to support culturally responsive early learning, and EI/ECSE at recommended service levels for children with disabilities and delays.

Universal Home Visiting for Newborns and Parents

Implement Family Connects so all new parents have the option to have a nurse visit in the first weeks after returning home with a newborn.
