

## House Veterans and Emergency Preparedness Committee Oregon Department of Veterans' Affairs Testimony House Bill 2530 |February 12, 2019

#### Summary

House Bill 2530 establishes a Legislative Task Force on innovative housing strategies. The purpose of this testimony is to brief the House Veterans and Emergency Preparedness Committee on Oregon Department of Veterans' Affairs' current initiatives and efforts to address housing and homelessness using innovative strategies, including its efforts in partnership with Oregon Housing and Community Services.

#### Innovations to Address Housing and Homelessness: ODVA Partnership with OHCS

In the 2017-2019 Oregon Department of Veterans Affairs (ODVA) Legislatively Adopted Budget, a budget note directed \$1.5 million in lottery funds to go to Oregon Housing and Community Services (OHCS). The budget note directed OHCS to work with ODVA to develop a collaborative plan for expenditure of these funds and to report to the Legislature in the February 2018. (See 2018 ODVA/OHCS Legislative Report)

Oregon Department of Veterans' Affairs has a strong partnership with Oregon Housing and Community Services on the implementation plan that includes:

- OHCS hired a Veteran Homelessness Integrator Position
- Increased Community Action Agency (CAA) Veteran Services Funding
  This is the "boots on the ground," direct services to veterans on a local level
- OHCS and ODVA co-hosted two Homeless Convening conferences, brining local partners from across the state together for two days to collaborate on ways to address veteran homelessness; a third conference is planned for Summer 2019
- Funds provided Permanent Housing for Homeless Veterans; able to fund an additional OHCS Multifamily Housing NOFA project

- Operation Welcome Home (OWH)
  - OHCS and ODVA are collaborating with 10 communities to house 500 homeless veterans across Oregon.
  - Campaign focuses on building a local veteran leadership team; providing contracted technical assistance to develop and work with a veteran by-name list
  - In support of OWH, a limited-duration committee was established to advise and assist the 10 communities in overcoming barriers to housing homeless veterans.
     OHCS and ODVA are staffing this committee

### Innovations to Address Housing and Homelessness: Veteran Service Grant Program

In the early Spring of 2017, Oregon Department of Veterans' Affairs (ODVA) funded a number of grants through the Veteran Services Grant Program that was established under House Bill 2891 (2017). The program awarded \$550,000 to 10 proposals. Many of the proposals focused on housing and homeless with all or a portion of the grant funds. A complete list of the grants is attached as Exhibit A. These grants provide local community organizations with the capacity to bring creativity and innovation to address housing and homelessness, including:

- **Polk County Family and Community Outreach Department** provides homeless veterans meals, stable transitional housing, laundry and showers, and connections to veteran service organizations.
- **Oregon City Police Department** first responder for veteran homelessness prevention and assistance. Rental assistance and job training assistance.
- **St. Andrew Legal Clinic** full legal services to veterans with a focus on issues of economic stability and housing security.
- Klamath/Lake Community Action Services emergency housing for veterans/families awaiting rehousing/permanent housing.
- Native American Rehabilitation Association of the NW Outreach and case management for Native American/Alaska Indian homeless veterans to address health/mental health care and housing.

### Innovations to Address Housing and Homelessness: ODVA's Efforts for Underserved Veterans

• Oregon Department of Veterans' Affairs' Incarcerated, LGBTQ and Women Veterans Coordinators work directly with at risk veterans, and state, federal and local community partners to help connect veterans to local housing and support services

### Innovations to Address Housing and Homelessness: ODVA's Future Efforts 2019-21

• ODVA will target gaps in veterans housing and homeless services in its 2019-21 budget through a grant program for local organizations plus a homeless veteran coordinator position for a total of \$1 million
