# What is HSPR?

- Health Security, Preparedness and Response program.
- Coordinate within OHA programs and with Tribal, local, and state agencies to support the public health and healthcare systems during emergencies or disasters.
- 100% federally funded by the Centers for Disease Control and Prevention (CDC) and Assistant Secretary for Preparedness and Response (ASPR)



# Why a healthcare volunteer registry?

- 9/11 Highlighted gaps
- 2002: National registry mandate
  - Emergency Systems for Advance Registration of Volunteer Healthcare Professionals (ESAR-VHP)
  - In Oregon, called SERV-OR.








# **Volunteer organizations in SERV-OR**

- Medical Reserve Corps (MRC)
  - A national program housed in the Office of the Assistant Secretary for Preparedness and Response, US Department of Health and Human Services
  - First units started in 2002
  - Locally administered resource in Oregon
- State Managed Volunteer Pool (SMVP)
  - Available for statewide response
  - Many also belong to their local MRC unit
  - Only respond to Governor declared emergencies
  - Volunteers and SERV-OR system managed by HSPR staff

# **Volunteer organizations in SERV-OR**


- Oregon Disaster Medical Team

  - OVERT
  - Response resource within Oregon Department of Agriculture (ODA) Division of Animal Health and Identification (AHID).
  - Mass animal sheltering; zoonotic diseases.
