I am writing in regards to the House Bill 3063 to inform you that as a United States citizen and resident of Oregon I am opposed to mandatory vaccines in Oregon. I used to be pro-vaccine but my views have recently changed. I've become aware of the fact that the vaccine industry is reckless with major room for error. Parents aren't being truthfully informed of the risks or potential side effects of vaccines and children are suffering for it with side effects sometimes resulting in permanent disability or death. Doctors and nurses aren't being required to know important safety information regarding vaccines. The vaccine companies aren't responsible for vaccine injuries or death.

With the industry proving negligent with great risks to the children in our community I believe parents should choose if they want to take that risk or not. Most parents aren't informed enough to even make a proper decision but the ones of us who are should not be forced. We have spent hours upon hours researching to make a highly educated decision regarding each vaccine offered to our children. There's lots of things we don't understand yet about how vaccines react to each individual. They are not recommended (according to the vaccine inserts) during pregnancy or to children with compromised immune systems. Some children have a predisposition to health problems that could be fatal if receiving a vaccine but those are overlooked.
