Hello My name is Holly Garland,

I am against HB 3063, I oppose HB 3063.

I was born in Oregon, went to Oregon public schools, graduated from an Oregon public school and went to Oregon colleges. I live at 22085 SW Augusta Lane Hillsboro, OR 97123 I am a U.S. Navy Veteran. I am vaccine damaged. Before I went into the Navy they did a full physical on me at the MEPS facility in Portland, OR there was absolutely nothing wrong with me at 21 years of age. Boot camp where after three weeks of vaccinations I succumbed to bronchitis & pneumonia at the same time I developed an allergy I never had before. I am now allergic to Sucrets lozenges only 2% of the population is and now I am part of that 2%. Now I also have two astigmatisms, and two learning disabilities. I was never given any information about the risks, of vaccines If I could do it all over again I would not go into any form of military because of the health problems I have developed because of vaccines. I have gotten the Anthrax vaccine and all its boosters and yes it had rotten side effects like a rash that showed up where you had gotten the shot administered two weeks later that was roughly the size of your hand that was so itchy and hot we would cut all our finger nails off so we would damage our skin as little as possible. We would also put ice packs on our arms because it would feel like our arms were melting where the vaccine had been administered two weeks earlier. I know I wasn't alone & everyone knew what had caused this problem a ships compliment of three hundred and thirty people all having the same reaction couldn't just be coincidence.

My daughter had four bad vaccine reactions when she was seven years old. I called the doctor and she said it couldn't be the vaccines, I ask how could it naught be, it had been less than eight hours ago that my daughter had gotten the shots and the side effects from the sheet of paper that had been given to me where what I was telling her about. I didn't know about VAERS back then I didn't know I could report for myself, I really didn't have a clue what to do. I have my daughter in better health these days compared to back then, however I am still paying off the medical bills, I have finished paying the first mortgage on my house and now have \$90,000.00 left to pay of a \$98,000.00 second mortgage that was used for medical bills. How does a child who was a social butterfly become anxious and depressed? How does a happy child become withdrawn and angry? The state of Oregon doesn't pay my medical bills nor my child's medical bills, therefore the state needs to keep it's nose out of the choice to vaccinate or not to vaccinate.

If vaccine worked so well why did the U.S. Congress feel the need to pass https://www.congress.gov/bill/99th-congress/house-bill/5546 into law in 1986. Vaccines manufacturers and the doctors who administer vaccines are granted complete immunity of liability for vaccine injuries and deaths caused by vaccines. The National Vaccine Injury Compensation Program and the 2011 Supreme Court Decision https://www.supremecourt.gov/opinions/10pdf/09-152.pdf which in its fifty-seven page decision said Vaccines are Unavoidably Unsafe. These two things created a blank check for Vaccine Manufactures. Vaccine Manufactures can not be sued. The United states is the only country that Vaccine Manufactures can not be sued in. It is just common sense to ask if a product is so great why does it need to be mandated (probably because it really isn't a very good product at all.) You don't have to be a doctor or a specialist to figure this out, anyone who has had an education through seventh grade can do it if you took a science class.

HB 3063 is an unethical bill it makes me think of Nazi Germany, doctor Joseph Mengele who thought children were less than fully human and therefore it is alright to experiment on them. This form of thinking is called Eugenics and this bill is the beginning of bringing back Eugenics to Oregon. The Nuremberg Code was made after this world war because vaccines were introduces in the 1930's and Autism was first document in the 1940"s in medical journals

https://history.nih.gov/research/downloads/nuremberg.pdf . HB 3063 violates the Nuremberg Code and discriminates against lower to middle income house holds.

The smallest minority on earth is the individual, those who deny individual rights can not claim to be defenders of minorities. Oregon should learn to be more like Arizona who just passed three laws insuring better informed choice when it comes to vaccines and now Texas is making it easier for parents to have informed choice for vaccines. If HB33063 passes into law those states are most likely where parents who understand the importance of medical freedom when it comes to vaccine choice will move taking 14K per child out of Oregon's school budget at 31,521 students. That is \$441,294,000 out of Oregon schools that will not help pay for PERS. Oregon already has financial problems. Oregon doesn't need to add to them with this completely unethical bill that will cause financial problems for parents to pay deductibles and loss of pay for having to take time off of work to go to the doctors office these are hardships for middle and lower income house holds. It is pretty much impossible to get a medical exemption in Oregon after SB 277 passed in California because elected officials there said they would not harass doctors who gave medical exemptions and yet that is exactly what is happening. If philosophical and religious exemptions are taken away in Oregon someone might just file a lawsuit against the state for violating their first amendment rights more money the state doesn't need to be wasting since only 2.6%

of students in K-12 are 100% unvaccinated so that means of the people who filed an exemption, 66% of them partially vaccinated their kids! (Because only 2.6% of the 7.5% of exemptions did no vaccines, that means 4.9% did vaccinate, 4.9/7.5=65%).

over time as a new vaccine is added to the schedule, parents are opting out until they are ready. I mean what infant needs a Hep B vaccine on the first day of their life, I don't know of any parents who are gonna use a drug needle on an infant the first day of life or pimp them out on there first day of life and since you can only get Hep B through needle or sex it's reasonable to say no to this particular vaccine for an infant that is less than a day old. How many of you know that the Vitamin K shot has a black box warning, that is the most sever warning given for a shot. It appears on a prescription drug's label and is designed to call attention to serious or life-threatening risks.

HB 3063 also provides an argument for Taxation with out Representation, the state would be taking peoples taxes and not allowing their children an education, that is another potential lawsuit, tax payers in Oregon have paid for enough botched crap like the Oregon Health Plan, that never came to fruition. Please don't make problems where there are none for Taxpayers to have to clean up.

Lets just ask some common sense questions after 33 years and Billions of dollars isn't it time to repeal https://www.congress.gov/bill/99th-congress/house-bill/5546 30 billion dollars a year and growing. What motivation does a vaccine manufacture have to improve it's product and insure that it is safe if they never have to feel the financial sting of hurting those who are forced by the jack boot of government to take all 72 recommend dosses. Why does the CDC have over fifty vaccine patents? What ever happened to first do no harm? Why do vaccines have a lower standard of testing than any other

They are both currently costing the state hundreds of thousands of dollars in special education and for after school caregivers that the state pays for. The question that plagues these parents minds on a daily basis is when I die who will care for my Autistic child and what kind of quality of life will he have when I am gone.

HB 3063 is a bad bill. There are too many reasons to list for me to write them all down for you now as to why you should vote NO on HB 3063. Please do the math and connect the dots this bill will only do harm with unintended consequences.
