To Whom it May Concern,

I am writing to express my concerns for **HB 3063**. While I am not opposed to vaccinating, I also feel it is extremely important to afford people a choice when it comes to their children's wellbeing. If vaccines were 100% safe and effective, then the choice to vaccinate would be a no-brainer for many of us. Unfortunately, there is actual cause for concern when it comes to the possibility of an adverse reaction from a vaccine, and sometimes those reactions can be life altering or life threatening. I am not talking about the MMR vaccine causing autism- we all know that myth has been debunked. However, there is enough research and cautionary statements from both vaccine manufacturers and the VAERS reporting system (regulated by the CDC and the FDA) that demonstrate the fact that vaccines carry their own inherent risks.

Part of this risk is due to some of the additive ingredients in vaccines. The most alarming to me are Aluminum, Polysorbate 80, FORMALDEHYDE, ABORTED FETAL TISSUE AND ANIMAL DNA. Aluminum mixed with Polysorbate 80 crosses the blood brain barrier. The amount of aluminum far exceeds the safe recommended dose in just one vaccine.
