Dear Representatives and Health Care Committee Members,

We oppose HB 3063.

My family and I live here in Oregon and we believe any bill that would attempt to limit health choice or vaccine choice is unconstitutional. To require someone to take a vaccine or to limit their option to refuse one is an attempt to displace body autonomy and health freedom. Additionally:

Nothing medical is ever one size fits all.

And no body detoxes the same way or handles medicines or vaccines the same way. Please think of how alcohol affects people vastly different as a clear example.

We know so many people hurt and harmed by the vaccines themselves - including close friends, many family members and myself. Why do you attempt to ignore our voices and our stories? When you speak of the scientific approach, why do you discount this side of the data? Why are you biased towards pharmaceutical corporations and those that directly benefit from the sale and use of vaccines as indicated by the very introduction of this bill?

Our reasons for denying vaccines are many and are our own. We shouldn't have to explain our private experiences to anyone. Even in the name of health care, disease prevention or publoc health. And especially not because of media fear mongering and the slick words of those who directly profit from their continued use. Our body, our choice has never rung more true. Hear us!

For example:

My friend's infant son went into cardiac arrest in his pediatrician's office directly upon being vaccinated. Luckily, he was revived and survived. However, he was forever harmed by the vaccines they gave him that day. What if that was your child?

Regarding myself; my body formed a knot around the vaccine toxins injected into my arm which then popped and tore my bicep tendon. As you can imagine it was incredibly painful and a very long and painful recovery. I still have trouble with it to this day, 21 years later. I wish I had never had any vaccines. That is an incredibly irresponsible approach! This should be a red flag!

If you choose to only listen to a biased pharmaceutical sided solution, that is a myopic approach that is essentially putting all of your eggs in one basket. It is best to diversify your interests, and not be beholden only to the

pharmaceutical perspective or to attempt to limit another persons health perspective. Just because of an

exagerated fear of a worst case scenario of disease does not make it an epidemic or an infectious reality.

Many of us understand the functions of these diseases, respect the bodies inherent immune system intelligence and are not afraid of protecting and healing the body by other means, such as nutritionally. For many people vaccines have done more damage than good. And we find ourselves trading once benign and temporary childhood illnesses for life-long auto-immune issues, injuries and lifetimes of suffering.

Science continues to advance rapidly. Vaccines are simply not the only answer anymore. It is not wise or ethical to limit or remove the ability for a person to choose the approach that is right for them. To attempt to do so would only continue the ridiculous facade of vaccine effectiveness claims, limit real scientific discussions and enable further pharmaceutical dependence and allow more manipulation.

You simply cannot limit the conversation or silence the contradicting data we present by mandating or removing vaccine choice. The problems of vaccine flaws and failures lay within the vaccines themselves and will not simply go away by mandating their increased use.

Of course they are going to talk them up as much as they can while simultaneously refusing to listen to us or to anything that dares to contradict their now well established dogma. As a vaccine injured person this is infuriating!

For example:

To go to a doctor, perhaps about a foot injury, and to then be lectured to about a flu shot instead is utterly ridiculous. No wonder misdiagnosis is rampart! Vaccine recommendations and requirements are interfering with real health care.

The reality is there are many, many options that are effective and not pharmaceutically based or fear based. Please do not limit your definition of health, health care or disease prevention to the concept of vaccines. Do not attempt to limit health choice or body autonomy. To do so would truly be a step backwards for our society.

Do not let yourself be manipulated by such fear based media frenzies. There is no measles epidemic.
