Chair Salinas and members of the House Committee on Health Care:

I am Susan Jorg, a graduate of Oregon State, and I am opposed to HB 3063.

There are two sides to the vaccine debate. On one side the CDC, FDA, WHO, Oregon Health Authority, doctors and nurses <u>predict</u> dreadful consequences if we don't have 100% compliance to their vaccine schedule.

On other side doctors and nurses, lawyers, research scientists, and parents report that something dreadful <u>is happening right now</u> to our children. We are raising our voices loudly to let you know that chronic disease in children is skyrocketing from 3% when I was a child to a current 54%, and we are pointing at vaccines as a likely cause.

Yehuda Shoenfeld, a highly respected Israeli clinician, has spent more than three decades studying the human immune system. His discovery, ASIA - or Autoimmune/inflammatory Syndrome Induced by Adjuvants (also known as Shoenfeld's syndrome) -- first appeared in the Journal of Autoimmunology four years ago. It is an umbrella term for a collection of similar symptoms. He shows that the metal aluminum used in vaccines, can trigger an immune system chain reaction in <u>susceptible</u> individuals and may lead to overt autoimmune disease.

In 2018 Christopher Exley, British researcher, dissected brain tissue from victims of autism and found the aluminium content in the brain tissue was consistently high. And Romain Gherardi, French researcher, has shown how aluminum adjuvants in vaccines can migrate from the injection site to the brain and become highly bio-persistent, or hang around for decades. <u>https://www.sciencedirect.com/science/article/pii/S0946672X17308763#!</u>

Another large flaw in the system is that we are not accurately capturing the real numbers of vaccine injury because the Vaccine Adverse Events Reporting System is voluntary, unadvertised, and under-utilized. Unfortunately the medical system provides no tests for determining who is susceptible to vaccine injury. They seem even irritated that we should ask for caution until some means of testing for susceptibility is found. If they don't test for it, they are not giving out medical exemptions for it. And families need exemptions to protect themselves from this large unknown.

I hope this committee will be diligent and clear sighted in your duty to the citizens of Oregon. Should we be worried about 63 cases of measles as the OHA tells us to be, a disease that resolves itself in a couple weeks. Or should we be concerned about thousands of children devastated by chronic auto-immune diseases that are now known to be caused by vaccines.

HB 3063 puts us at the mercy of the medical system. A medical system that is reported by Johns Hopkins Medicine to be the third leading cause of death in the United States due to medical errors. I believe HB 3063 will be one of those medical errors.
