To whom it may concern:

I am a voter and resident of Douglas County, Oregon.

Please vote against HB3063.

Please consider the following when voting on HB3063:

Medical freedom is a basic human right. We own our bodies and we have the right to choose what goes into our children's bodies. You work for us, not the pharmaceutical companies. They are not held responsible for their mistakes and people pay the price for their mistakes.

Pushing parents to go against their moral values and decisions they make for their families will cause more people to push back against these mandates. You already have a very high compliance rate. Only 2.6% of students in K-12 are 100% unvaccinated so that means of the people who filed an exemption, 66% of them partially vaccinated their kids! (Because only 2.6% of the 7.5% of exemptions did no vaccines, that means 4.9% did vaccinate, $4.9/7.5=65\%$)

It gives OHA the authority to add any new vaccines

This bill allows any vaccine to be added to the schedule without scrutiny. It is not in the best interest of the people. Where is the cut off? When will it be too much? For some children it already is too much. Their bodies cannot handle the toxic load. Why do we have to wait for them to be injured before they can get an exemption?

Parents want the freedom to choose which vaccinations are appropriate for their children, especially as the list grows and grows along with the greed of pharmaceutical companies. We know our family history and our children's medical history.

Families have to get exemptions if they want to turn down even just one of the 18 vaccines on the schedule. If I have one child who had a reaction to one vaccine and I don't want to give it to them again, or to one of their siblings, it is a risk I have weighed. It is my right to accept or deny any medical intervention for my child. I should not have to go through the bureaucracy of medical specialists who have their own agendas and get big bonuses for having all of their patients fully vaccinated. (Conflict of interest!) We have been booted out of a practice for not accepting one vaccine because of a previous reaction. This will restrict access to medical care more and more.

Medical exemptions are not given out in Oregon. My family should have a medical exemption because of reactions (that were not documented by doctors who denied it happened, we were gas-lighted by medical professionals!), because of a family history of autoimmune diseases triggered by vaccines, as well as a gene mutation (MTHFR) which reduces the detoxification of many chemical found in the adjuvants of vaccines. When we asked for a medical exemption we were told it was easier just to file for a waiver, to watch a video and sign the form. Nobody wrote down our adverse reactions and nobody reported them to VARS and so there is no record to even go back and get a medical exemption from. Also a lot of the allowed exemptions require you to vaccinate and have a severe reaction first, when there are

many ways the reaction could be avoided first. There are avoidable errors!

In the long-term it will become a financial burden to the whole system.

There are gene mutations and variants that should be medically contraindicated with vaccines that aren't even well known or accepted yet. Legislation will always be way behind the science and there is a huge risk not only to the health of our families, but also to the possible cost on the entire system if those who support vaccines are wrong about their safety!

Where there is a risk there has to always be a choice. Parents demand medical and educational freedom in this country. Vaccination rates are not a public health crisis. There are so many viruses we do not have vaccines for that our bodies are able to fight off. Many people have stronger immune systems if they encounter and fight off viruses in the wild. Vaccination is not the same as natural immunity. Those with compromised immune systems (like me) are not protected by the myth of herd immunity. Nothing is ever settled in science. Real scientists question everything! They keep asking questions and solving problems. I'm eager for more research to make vaccines even more safe and effective. We cannot accept the risks they provide today and must demand better.

Please respect parental rights to choose what is best for our children. Please say NO to HB3063
