## To Whom It May Concern,

I am writing to express my unease and opposition to Vaccination Bill HB 3063. Before I address my specific concerns around the inherent danger of vaccines themselves, I'd like to speak to the larger issue at hand and that is the suggestion to take away the freedoms and rights of others.
