

Chairwoman Salinas and members of the committee:

My name is Robert Snee, I am a practicing attorney from Clackamas, the father of two partially vaccinated young adults, and I am an ex vaxxer who once believed the greatest marketing lie in history, that vaccines are "safe and effective," and I'm here to testify in opposition to HB 3063. The truth, as I've discovered in my twenty plus years of research is that they are not 100% safe nor 100% effective, and for some people with otherwise benign mitochondrial disorders or immune system issues, they are 100% unsafe. Vaccines are however, 100% liability free for the pharmaceutical industry.

If we get into a debate about safety and efficacy of vaccines, we can get lost in a hopeless jungle of details that will divide and confuse. There is a far more basic issue: Do we own and are we sovereign over our own bodies? Who has the right to control what medical procedures we subject our bodies and our children's bodies to?

Four years ago, while testifying in front of the Senate Health Committee against SB 442, a nearly identical bill, I cautioned the Senators that the day Dr. Benjamin Rush, a signer of the Declaration of Independence and delegate at the Constitutional Convention, had warned Americans about, had arrived.

"Unless we put medical freedom into the Constitution; the time will come when medicine will organize into an undercover dictatorship and force people, who wish doctors and treatments of their own choice, to submit to only what the dictating outfit offers. The Constitution of the Republic should make a Special provision for medical freedoms as well as religious freedom."

That same year, political scientist John West wrote that, "We've entered the age of totalitarian science," and nothing I've observed over the past four years has convinced me he was wrong or that our government hasn't become totalitarian.

As I sit here today, and I reflect on the events over the past two months, I am both angry and afraid for myself and my future grandchildren, and ashamed of those we've elected to represent us who are willing to sacrifice our basic human rights and freedom. For not only was Dr. Rush an astute prophet, but so was George Orwell, and the dystopian society described in his book, "1984" of omnipresent government surveillance and public manipulation has become our reality. That public manipulation has been put into play by the following events which have occurred over the past two months:

- World Health Organization declares "anti-vaxxers" as global health threat
- Golden Globes pushing heavy influence on crowd accepted "flu shots"
- Measles "outbreak" in several states
- Cue declaration of "emergency" by WA State governor (less than 65 cases)
- Legislation is drafted in over 33 states - some bills more draconian than others.
- Funding from Pharmaceutical companies to back state and federal Representatives (Pharma's lobbying outspend oil and gas lobbyists fourfold)
- Cue follow up legislation going after religion and homeschoolers
- Fast track of 6 in 1 vaccine VAXELIS - several babies died during clinical trials to be added to the infant schedule
- Cue Social Media platform threat of removal of any and all information that reveals the dangers of vaccines (encouraged by a US Rep from CA)
Pinterest has already removed many posts and Facebook is threatening to do the same
- Media encourages segregation, hate, violence and discrimination towards anyone who questions vaccines. The vaccine injured and risk awareness advocates have become the only group that is socially acceptable to bully

If we step back and analyze the events in their totality, it becomes obvious that we are being socially engineered to pursue a course not of our own choosing.

Surprisingly, in a hearing regarding drug pricing on Tuesday before the US Senate

involving executives from 7 pharmaceutical companies, Oregon's senior Senator described Pharma as "morally repugnant." Yet when it comes to vaccines, the media, (which gets 70% of its advertising dollars from Pharma), tells us repeatedly how virtuous pharma is.

I mentioned Orwell and it is somewhat ironic that the FDA stated in the Federal Register on June 1, 1984, while referring to the oral polio vaccine, that,

". . . any possible doubts, **whether or not well founded**, about the safety of the vaccine **cannot be allowed** to exist in view of the need to assure that the vaccine will continue to be used to the maximum extent."

This statement has become the de facto government policy regarding all vaccines. It is a call for censorship of serious and relevant scientific data, which puts individuals at risk, and it is demonstrated in everything we hear from government health agencies and the corporate mainstream media. Government misinformation was blatant just yesterday, as a CDC doctor testifying before a U. S. House committee, lied under oath when he said the MMR vaccine never causes encephalitis. If you look at the Vaccine Injury Table used by the Vaccine Injury Compensation Program, encephalitis is a recognized and compensable injury caused by the MMR vaccine. The VICP is a program solely funded by consumers and by which over \$4 billion dollars has been paid out to people injured by vaccines.

Make no mistake about it. When our laws require children to get an education but in order to get that education, you intend to pass a law giving people no choice but to vaccinate their child with every vaccine now on the recommended schedule, as well every vaccine created in the future and added to the schedule, that is legally defined as coercion.

When medicine must be forced upon the population by force and coercion, it becomes a mockery of the very thing it claims to stand for: “First, do no harm.” Any system of medicine that must use coercion in order to achieve compliance is no system of medicine at all... it is brute-force tyranny carried out under the false banner of “public health.”

Nearly all political democrats in America currently believe it is a woman’s choice to end the life of an unborn child, but they simultaneously hold the contradictory belief that women should have no choice whatsoever about whether to inject their children with toxic mercury and other chemicals still used in vaccines. In fact, of the 62 different vaccine formulas published by the CDC, 32 of them contain either, 1, 2, or as many as 3 of the chemicals listed by Oregon as High Priority Chemicals of Concern, under the Toxic Free Kids Act many of you voted in favor of and passed four years ago. A vote in favor of the bill tells Oregonians that a mother’s choice ends when the child is born, at which point the state is becoming the parent and therefore dictates all health choices affecting the child. All in the name of “public health.”

What I am also scared of, is something the Oregon Health Authority boasts about as they tout the virtues of vaccines. Of particular concern was their statement that “future vaccines may modify DNA to prevent diseases.” That future is here and now. Personally, I don’t wish to have my DNA synthetically altered against my will and I, and every individual, ought to have the right to to make that decision for themselves.

This nation was founded on the principles of individual freedom and liberty, and the Bill of Rights were adopted as amendments to the U.S. Constitution to ensure that government never overreached and trampled upon the rights of an individual. Oregon’s

Constitution was adopted following those same principles. HB 3063 will trample and shred Oregonian's fundamental rights protected under the U.S. and Oregon Constitutions.

If government in America is allowed to force its fellow citizens to risk injury or death without their voluntary, informed consent, or even to alter a person's DNA, then we are no longer free Americans. Our bodies will then be owned by the state and can be sacrificed by the will of the state. Once you take away a parent's right to make medical decisions based on informed consent for their children, it is only a short step before everyone loses that right to determine what substances will enter their body, since mandatory adult vaccines will quickly follow.

As citizens, we must demand accountability of our government and demand our government protect our rights, not disregard them for "public health." If HB3063 becomes law, then the promises of freedom and liberty that this nation were founded upon, are nothing but a sham and an illusion.
