It is critical that Vacation Rentals be allowed in only limited areas of a City. It has been a free for all to put a vacation rental anywhere.

This has caused an epidemic in lack of standard rentals for

Vacation Rentals has eliminated a huge % of regular housing rental available. Coastal Communities can't provide housing for the jobs available.
