As an Oregon citizen, parent, and concerned human being, I strongly oppose HB3063.

Do not allow yourselves to be manipulated by the biggest drug cartel in the world – the pharmaceutical industry – which has bought and paid for our medical schools, media, and public health departments. As representatives of the people of the great state of Oregon, you must TAKE AN OBJECTIVE and THOROUGH look at vaccine mandates! A few cases of measles in a population of over 4,000,000 IS NOT AN EMERGENCY...please take your time to discern the right decision.

There is much truth hidden in plain sight.

I personally know many families with children who have been seriously harmed by vaccines...injuries that will plague them throughout their life. My daughter has gone to school with several vaccine-injured kids, and she dealt with more while volunteering at a preschool. These children are challenged in ways that are much more serious and chronic than when I was a kid and we all had measles, mumps, rubella and/or chicken pox. It breaks my heart to hear some of the stories she tells about her interaction with and observation of these children.

And the preponderance of injuries that we have seen personally demonstrates the absurdity of the commonly heard claim that only "one in a million" vaccines cause a severe reaction. Maybe only one in a million children drop dead in their doctor's office, but most vaccine injuries are delayed and not quite as conspicuous as that.

To deny education to families like ours who choose not to vaccinate after we study the risks, benefits, family health history and history of our individual child, is a violation of our rights as Americans. This country was founded on freedom. It is not the Oregon Legislator's place to circumvent the very foundation of our democracy.

And to tell families that they can just homeschool their children if they cannot, in good conscience, subject them to these poorly tested medicines, is absurd. Our daughter homeschooled for a time and it was very hard, even though she is quite smart and my husband and I work from home, so we were here to help. She was socially isolated, she had to spend way too much time on the computer doing schoolwork, and she didn't learn as much as she would have in school. For families with both spouses working away from home, as well as single-parent families, homeschooling would be nearly impossible. Telling them they must do this is discriminatory, and it will cause the greatest harm to lower income families.

Now that my daughter is a teenager and has learned a lot about vaccines that's never mentioned in the pharma-controlled media, she will not permit her body to be poisoned by vaccines should this legislation pass. Instead, she will drop out of high school, and she will not be able to attend college in Oregon. It's outrageous that a few cases of measles in a population of over 4,000,000 should cause such hysteria as to ruin the lives of the many young people who see through this pharma-funded push to eliminate a disease that's so rare in our country.

And if it's measles people are so worried about, why isn't there a vaccine for just that disease (without the addition of mumps and rubella)? I imagine many families who have opted out of the MMR might consider a single shot for measles. And since Merck is being sued by two virologist-whistleblowers about the efficacy of their mumps vaccine, and rubella is a relatively mild disease, skipping the rest of the vaccine cocktail (MR) would not be a big deal to most.

Vaccines have very real and serious risks. And proper, placebo-controlled safety testing has not been

done for individual vaccines, nor for the extremely bloated vaccine schedule as a whole (see attached list). The National Childhood Vaccine Injury Act of 1986 compelled the U.S. Department of Health and Human Services to improve the efficacy and safety of vaccines. The act required continuous monitoring and improving of adverse event reporting and a report to Congress at least every two years. It has been over 30 years since the act was put into place, but ZERO REPORTS have been provided to Congress. And the U.S. Court of Federal Claims (vaccine court), established by the act, has paid out over \$4 billion in claims for injuries! And this has happened even though most families do not even know the court exists, it is extremely difficult to get favorable resolution to a case, and the Vaccine Adverse Event Reporting System (VAERS), which was set up to monitor safety, has been shown to be highly inaccurate...representing only 1 to 10% of adverse events.

As I stated above, a few cases of measles in a state of over 4,000,000 IS NOT AN EMERGENCY! I realize that third world countries have a significant problem with measles, but in the USA this is not true. And should it become true someday, I imagine most families would then choose to vaccinate, especially if a measles vaccine was available by itself.

HOT OFF THE PRESSES: Of 30 recent cases of pertussis in a California school, all the children were vaccinated, and none of the unvaccinated kids got sick. (see "Officials deny lack of vaccinations caused whooping cough outbreak in Los Angeles" at https://thehill.com/homenews/state-watch/431848-officials-deny-lack-of-vaccinations-caused-whooping-cough-outbreak-in) So much for the allegation that unvaccinated children are spreading disease. Maybe vaccine mandates won't solve all our problems.

And perhaps vaccines cause so much damage to our immune system they really do more harm than good. BINGO!

In closing I ask you to remember that after WWII, the war against what was supposed to be the most-evil regime in human history, the Nuremberg Code was established, stating that forced experimentation on humans is wrong, and that informed consent is necessary for every medical procedure. How have we permitted our medical system to stray so far from this life-saving doctrine, and from the Hippocratic Oath "First, do no harm".

Please do not pass HB3603 out of your committee. Our children are counting on you.
