I am a resident of Bend, Oregon. I am the mother of a one of a half-year-old son and expecting another next child. I have a Masters Degree in Oriental Medicine and graduated in 2015. I have friends who have followed the CDC schedule, whose children had adverse side effects. While interning at Oregon College of Oriental Medicine witnessed children with vaccine side effects and developmental regression. There are many reasons that many parents have made educated decisions to choose not to vaccinate their children. It would be against our constitutional rights and medical freedom to mandate vaccinations. There is a relative of mine whose parents followed the CDC schedule, and has not been the same; he is a functional antisocial autistic citizen. There is a significant number of friends who trusted the doctors and the CDC schedule and tried to comply with the recommended vaccine schedule.

The big picture we need to look at is not mandating these vaccinations. We need to look at informed consent. In pursuing as a medical professional, medical professionals need to give complete informed consent on vaccines and their inserts as well as their risks. Since I had even received the Gardasil shot, which was recommended, at the doctor's office when I was 16. I now struggle with severe migraines and flashing auras, which I have never experienced before. I also saw a significant decline in my ability to comprehend my academics causing me to work that much harder than the other students in my graduate program. I could go on and on, and I know you have a lot of emails to read. I thank you for taking the time to hear my story, my concerns, and my thoughts.

I do not want my children to struggle in academics like I have and I do not want them to experience severe migraines and constant fatigue like me. I am asking for you to please help us oppose this bill and mandate, not vaccines but vaccine safety. Let us make the CDC accountable again for their products and have liability and accurate studies which reflect the safety of these vaccines. We need to repeal the 1986 Act.

We have a vaccine court. Why? Because there are so many vaccines injuries and we have paid 4 billion dollars out to vaccine-injured families.
