

Dear Madame Chair Andrea Salinas and Committee,

I am a very concerned mother in Salem. I was so emotionally moved by the stories of vaccine injured children. I can't help but fear this will pass despite all the opposition including those 180 of us who didn't get the opportunity to speak and not to mention those who didn't even know about this because you gave us 3 days' notice during a snow storm!

My son and I have the MTHFR genetic mutation. Do you know what that means? *A defective MTHFR gene creates a vulnerability to disease processes as detoxification is impaired, leaving the body more susceptible to oxidative stress, and less tolerant of toxins such as heavy metals.* Please learn about this.

**I would like to voice my extreme opposition to HB 3063.** HB 3063 is not about being pro-vaccine or anti-vaccine or ex-vaccine or anything in between. It is about removing our rights and our freedom as parents to make medical decisions for our children. Vaccine reactions are not rare. If they were, why would over \$4 billion dollars have been paid out by VAERS to date? Fewer than 1% of vaccine reactions are ever reported, per **CDC**.

This bill not **only DEPRIVES my son from public educations** but also includes state licensed daycare facilities. Its more than just an inconvenience, it's an assault on our personal lives and the decisions we make in our home.

If my son gets kicked out of daycare - I'd have to quit my job, and we can't survive on one income. **HOW IS THIS A CHOICE?**

My husband and I are Christians and we have strong convictions about our health and what we put into our bodies. I feel strongly that the information about vaccines, such as vaccine inserts, should not be withheld from parents, and that decisions like vaccinating need to only be between the physician and the family.

I am strongly opposed to abortion. I am strongly opposed to the ingredients and use of aborted fetal cell DNA in our vaccines today. Do you know how many vaccines contain aborted fetal cell DNA? What about the monkey kidney cells, calf serum, formaldehyde, polysorbate 80 and the list goes ON? **M E R C U R Y**. There is increasing scientific information emerging proving that vaccines are not safe for all people. Making a statement that everyone, regardless of genetics or health, can receive all vaccines with no risk of harm is ignorantly bold.
