Freedom to Decide

"The rise of mandatory and forced vaccination legislation should send a chill up every single American spine. That government can force you to accept any kind of medicine and inject you against your will is totalitarianism at its worst! The egregious form of state power is metastasizing." Dr. Ron Paul

Vaccines have not been proven safe and, in some cases, lead to permanent disabilities and/or fatal diseases. Citizens of Oregon should be able to make their own decision as to whether or not they and their children should be vaccinated.

First of all, many say that before vaccinations, infectious diseases were absolutely rampant. While at times they were, the decline in death by infectious disease began well before vaccines were ever introduced. Infectious disease deaths went down by nearly 90% before the first vaccine was ever

used. Public health measures, clean water systems and improved sanitation have led to this great decrease in diseases.

Secondly, in 1986, congress passed the National Childhood Vaccination Injury Act, protecting the manufacturers of vaccinations from any liability. This resulted in a host of new vaccinations that are neither safe nor effective. In 2016, Children under the age of two (whose immune systems are not fully developed) received almost 30 shots as opposed to the 10 received by the age of 6 in 1983. The companies that develop and produce these vaccinations use toxic, carcinogenic, genetically engineered and allergy causing substances such as mercury, formaldehyde, antifreeze, aluminum, MSG, detergents, GMOs,

Latex and many others. These sorts of toxins are known to cause cancer and brain damage or are linked to SIDS, dementia, seizures, leukemia, diabetes, autoimmune diseases, allergies and infertility.

Furthermore, in many cases, the cure is worse than the sickness. Most of the diseases that vaccinations "protect" against are not fatal nor do they leave permanent damage, and the chances of catching these diseases are very rare. Whereas brain damage, encephalopathy, permanent paralysis, spastic clonus, paraplegia, seizures, retardation, blindness and more can result from just one vaccination being given to an unknowingly health-comprised child. From 2003 to the present, there have been 2 reported deaths due to the measles, and yet there have been 127 deaths directly related to the measles vaccination during

that same time. Autism has increased from affecting 1 in 10,000 people in 1992 to 1 in 50 in 2016. The current statistics for American children under the age of 18 state are: 1 in 3 are overweight, 1 in 6 have learning disabilities, 1 in 9 have asthma, 1 in 10 have ADHD, 1 in 12 have food allergies, 1 in 20 have

seizures, and 1 in 50 have autism. These numbers have increased in a manner directly proportional to the number of vaccinations administered. This is not the sacrifice of a few to protect the many, this is America's future being destroyed!

In conclusion, vaccinations are unsafe and largely ineffective. They not only are ineffective at preventing the diseases they are supposed to, they also cause a myriad of chronic illnesses and even death. And, if they are truly effective, vaccinated children should not be in any way affected by non-vaccinated children. Citizens of Oregon must be able to make their own informed decisions as to whether or not they and their children should take the risk and be vaccinated.
