I and writing to ask you to vote no on House Bill 3065 that would take away Philosophical exemptions to vaccines.

My Son Josh was injured by the DPT vaccines causing grand mall seizures for years. My daughter Perla was injured by the MMR vaccines and the Gardasil vaccines.

I recently had an adverse side effects to the hepatitis B vaccine myself. I now have an auto immune disease because of hepatitis B vaccine. Alopecia. Alopecia is listed on the hepatitis B vaccine insert as one of the adverse side effects that can happen from the hepatitis B vaccine. To the dermatologist specialist thought that I would not need the injections anymore but now all of my hair has falling out again and the pain And inflammation is back in my scalp. So now I need to go back to the dermatologist specialist and pay more money. And I am in pain.

We Do you not have medical exemptions. I hear they are hard to get. However we use the philosophical exemption and are using it because of medical reasons. Most people that use the philosophical exemption are using it because they have had adverse side effects from vaccines. We should not have to have a medical exemption to stay away from vaccines that have injured us.

The CDC has recently added to the MMR are vaccine insert that anyone who has a family member with auto immune disease should not have the MMR vaccine. So my children or family members should not have the MMR vaccine yet they do not have medical exemptions. My grandbaby should not get the MMR vaccine yet the doctor is going to force her to have the vaccine and possibly be vaccine injured before she gives her a medical exemption. This should not have to happen we should be able to use the philosophical exemption.

My father Keith Lloyd died two weeks after having his last flu vaccine. It says right on the flu vaccine insert that death can be a side effect of this flu vaccine.
