To the Legislature,

I. Timothy A. Land, write here to state that I do not consent to HB 3063. I was educated here in Southern Oregon to a Graduate degree as a teacher for the youth of our great state. With this degree, it is understood that I know the skills to perform, and the value and importance of doing research in order to educate others. As a parent of an 8-year-old son, I have a vested interest in investigating anything that could cause him harm while looking out for his well being. In my extensive research on the safety and efficacy of vaccinations, I have concluded that the risks far outweigh the proposed benefits for my son, my students, and my community here in our great state, as well as brothers and sisters from sea to shining sea and around the world. Conversations about vaccinations with my doctors and my son's doctors have given me enough information to deem that one vaccination may be one vaccination too many and that is a risk I am not willing to take. There has been no double-blind placebo-controlled studies on vaccines, nor has the development of this product advanced enough to look at the long-term effects the current CDC recommended schedule has on the health of our children and the role genetics and immunobiology play in their safety. Therefore, to mandate vaccinations equates to medically experimenting on my son against my consent and is in direct contradiction to the Nuremberg Code Point #1 stating the voluntary consent of the human subject is absolutely essential. Armed with this information and my belief in a higher power that many would call God. the Great Mystery or the Creator, I have chosen to exempt my son from vaccinations on religious and philosophical grounds. HB 3063 violates my Unalienable or Natural Rights granted by our Creator and protected through our Declaration of Independence, Constitution and Bill of Rights. The U.S. Constitution was written to protect the Natural Rights of each citizen from being tampered with by legislators. The 1st amendment states that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof ... " Therefore, it is impossible for a good-standing public servant of the Republic of the United States of America to protect this right and vote to remove the right of the people to choose an exemption from vaccines on the basis of religious and philosophical grounds. HB 3063 is tyrannical government overreach into what is going on in my son's and my student's persons. My son is a citizen of this great land. Please oppose HB 3063 and instead, focus your desire to protect our children by demanding true vaccination safety studies, make manufacturers of vaccinations liable for vaccine injuries and death and take the "Big Pharma" lobbyists out of the government.
