Chair Salinas and members of the House Committee on Health Care:

I am Susan Jorg, a graduate of Oregon State University, and I am opposed to HB 3063.

Since May 14, 1796 when Edward Jenner first scraped the pus from a cowpox blister and applied it to an open wound in the arm of James Phipps, governments have been involved in seducing their citizens to accept the practice of vaccination. Just as the side who wins the war gets to write history, the side with the most money and influence gets to write medical books.

Vaccination is the cornerstone of conventional medicine. Now that medicine in the United States is a for profit industry, vaccines are even more vital in keeping the pharmaceutical industry rolling in currency. "In 1973, Nixon, as a personal favor for his friend Edgar Kaiser, signed the Health Maintenance Organization Act which allowed hospitals, insurance companies, clinics and even doctors to function as for-profit entities." Since the passage of the 1986 National Childhood Vaccine Injury Act, pharmaceutical companies are free from liability if their vaccines injure or kill the recipient. Before the NCVIA, vaccine manufacturers were facing huge payouts for vaccine injury. Now they only profit and they don't have to invest in making vaccines safer because they're liability free. I bet the auto industry would like a sweet deal like this from our government.

Ever since 1986 the CDC has been adding vaccines to the childhood schedule, burgeoning from 23 doses in 1984 to 72 doses in 2018. (It was only 5 doses in 1963.) "Necessity no longer determines the validity of state childhood vaccination mandates.... The CDC and state health authorities are now the marketing arm for vaccine manufacturers, using scare tactics to funnel consumers into vaccine uptake. They have also succeeded in making everyone blind to vaccine injury. But the worst harm the NCVIA has done is to the citizens of Oregon and the nation who dutifully line their children up for vaccination only to become a statistic in the ever growing epidemic of auto-immune diseases.
