

To whom it may concern,

I am writing to urge you to oppose the HB-3063. This bill will take away my rights and my husbands rights as parents to choose what we feel is best for our children and their health. I am not writing to share the facts and data I have gathered through the last 2 years. I have put in countless hours considering my children's health and real immunity.

I am writing as a mom who is terrified to have medical freedom taken away from my family. I have always wanted to be a mother. I have 2 young children of my own, a 2 year old son and a 1 year old daughter. I am a step-mother to two grown children and I also raised my youngest niece.

I had no idea about the side effects of vaccines until the later years of raising my niece. I believe that she has vaccine related health issues and she hasn't had a recent vaccine other than the HPV. The morning after receiving the HPV vaccine and the flu shot, I was awakened by a huge bang noise that came from my bathroom. I ran into find my 14-year-old niece on the tile floor unconscious. She had passed out and hit her head on the floor from her fall. Days after this odd event she developed a rash all over her body as well as a high fever. We spent over 7 hours in our hospital's emergency room. The ER doctor ran countless tests and we left with zero answers. When we followed up with her pediatrician, she chalked it up to a sinus infection. Nothing about having a sinus infection would have caused any of these side effects my niece was experiencing. This girl is now 19 and has had diagnosis of ADHD, depression, anxiety and IBS. She has been so overly medicated it has caused more health problems. Vaccines aren't tested with medications to treat any of these health and behavioral issues.

My niece has a half brother who is autistic. I believe there is a correlation with how the adjuvants used in vaccines affect people differently. We do not all have the same genes and can't be treated as equals across the board from birth. We can't all be injected with the same chemicals and have the same outcome, it is insane to think this way.

This house bill will result in multiple injuries that are immune to liability by the manufactures. What are we going to do with the injured children? How are our public schools going to handle more special needs individuals that are vaccine injured? Why does my child have to potentially be injured to get a exemption? Once a child is injured they still have to receive all the vaccines except the one that caused injury.

I am raising my children as healthfully as I can. We eat mostly organic foods and an don't go out in public if we are sick, which is extremely rare. When did health become manufactured in an injection or a pill? Health comes from exposure and letting our immune systems created health and build antibodies and learn how to fight illness from within. Health does not come in a bottle or syringe.

My children share some of the same DNA as my niece and nephew who are vaccine injured so who is to say the vaccines won't do damage to them or worse...die? My children's father suffered from seizures at the age of 2 after a vaccination. My youngest step-daughter also had seizures following school recommended boosters. My children again share some of the same DNA.

How many children must be injured to prove this is a bad idea?

How have we lost our FREEDOM, the very thing that everyone preaches about day in and day out about our free country?

Why is it okay for our Health and Human Services to not be performing safety studies and efficacy studies on ALL vaccines? Why is the FDA allowing more than the recommended amount of aluminum in vaccines? Each vaccine has different amounts of neurotoxins and much of the vaccines are administered at the same time and not a single study showing effects of this asinine schedule.

We can't keep pretending that these studies exist, because they don't. You can't use one vaccine against another vaccine testing. Vaccines must have controlled placebo-based studies, not paid for by the drug manufactures. We need non-bias independent safety studies for all vaccines including the flu shot. Not only are my children going to be disallowed education by a system my tax dollars support, but we are now looking at segregation. My children and my family are already being targeted. My family's safety is already compromised. Please oppose this bill in the name of medical freedom and the freedom of our next generations.
