Dear state representatives,

I am very concerned about HB 3063 and the removal of personal exemptions on vaccination mandates. I have two primary reasons for concern. One is of medical freedom, and the other is of safety concerns.

I see a dangerous trend that is eroding our fundamental rights to informed consent on medical procedures. The Nuremberg code on ethical medical conduct states above all else *"The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him/her to make an understanding and enlightened decision." Taking away the right to exercising personal exemptions violates this fundamental principle of medical ethics.*

I understand the motivation for vaccine mandates and I believe that vaccines have been beneficial for the people of the world, but on the other hand, vaccines are also responsible for atrocities as well. Vaccines have been linked to sudden death, neurological damage, various auto-immune disorders, asthma, allergies, and the contraction of the very disease that the vaccine is supposed to prevent (e.g. vaccine inflicted polio infection).

I question the safety of the ever increasing list of vaccine co-ingredients or adjuvants. Many of them are linked to cancer and other diseases. I am concerned about the accumulative affect of all of these toxins. I fear that they are the root of many chronic diseases that are occurring at a greater frequency than ever before. Their long term safety has not been demonstrated.

I also object to being forced by law into the hands of pharmaceutical companies. The pharmaceutical industry is notorious for fraud. As a matter of fact, the very MMR vaccine that is causing so much controversy now is the subject of an anti-trust lawsuit over research fraud performed by Merck Pharmaceuticals.

The mandated vaccine schedule is constantly changing. There are more and more vaccines being added. If people are mandated by law to receive the

official vaccine recommendations, I have no doubt that vaccine manufacturers will take the liberty to create endless vaccines that 'we the people' will be forced to receive, and thanks to "The National Childhood Vaccine Injury Act of 1986," vaccine manufacturers are not held liable for any damage their products may inflict. Therefore, vaccine manufacturers have little incentive for insuring their products are safe.

The truth is, we cannot and should not attempt to inoculate away every type of infection. Our immune system needs to fight infections to remain adaptable and strong in the face of true epidemics. Infections teach our bodies how to fight future infections.

Ask yourself, are you certain that you will be 100% comfortable with vaccines that are added to the mandated list in the future? If you say "yes", then you are either guilty of not thinking critically or lying to prove a point. No critical thinker, no honest person, would ever sign off on the sight-unseen vaccine schedule of the future.

I personally do not want to live in a world where I am dictated by law to receive a medical procedure that may result in death or severe injury.
