Dear Health Care Committee.

I am writing to OPPOSE HB 3063 eliminating personal and religious exemptions pertaining to vaccines. I am a concerned parent. As a single Mother this would devastate my child and I greatly. He loves school and I am a valuable working community member. I would have to pull him out of school and so would a considerable amount of parents of the 31,152 children that will be excluded from school if this bill passes. As well as hundreds of thousands of others who will not comply with other vaccines added to the school schedule. I would lose my job because I am a single parent. This would likely put us into poverty. The exemption rates have not been accurately reported by the media and even our local officials. Oregon has high vaccination rates. An exemption includes a parent deciding to forgo one vaccine out of the 31 vaccines required for school. It is a parent's right to make an informed choice when it comes to which vaccines they feel comfortable giving to their children. With risk of death, paralysis, brain swelling and pages and pages of potential side effects, listed on the vaccine insert, parents have the right to weigh the risks. The rigorous vaccine schedule has never been tested on how it is affecting our children's health. This mandate will affect Oregon's already struggling school system dramatically and take away much needed funding when myself and other families decide that we have no other choice but to homeschool because we unequivocally disagree with a forced medical procedure on our children.

As a parent, I have spent many hours researching the best ways I can raise my child in an overly toxic society. Our children are inundated with chemicals in their food, water, clothing, medicine and overall environment. I read labels, I research ingredients and I make the best choices I possibly can with the disclosure that I am given about these products. When it comes to vaccinations I did the same thing. I found many concerning ingredients in the vaccines that are neurotoxin. The most alarming to me are **Aluminum, Polysorbate 80, FORMALDEHYDE, ABORTED FETAL TISSUE AND ANIMAL DNA. Aluminum mixed with Polysorbate 80 crosses the blood brain barrier.** The amount of aluminum far exceeds the safe recommended dose in just one vaccine. Many vaccines are three vaccines in one shot. And imagine how much aluminum is in one child's brain if they have received all the recommended vaccines and boosters by age 18. Most recently, Robert F. Kennedy sued the government, and won, because there have been no independent studies on how these vaccines are affecting our children for the last 30 years. As a part of the Vaccine Act of 1986, when pharmaceutical companies became exempt from liability the HHS Secretary was responsible for reporting their findings each year to Congress including safety and efficacy research, manufacturing and licensing research and adverse reaction reporting.
