RE: Please Oppose HB 3063!

I want first to thank everyone who shared their testimonies yesterday at the capital. I also want to thank you all the senators who oppose this bill on our behalf too. This bill is a violation of our medical freedom and our rights as citizens to make these important medical decisions for our families. If this bill passes, I will be forced to homeschool, but on that subject, even if I homeschool, I would not be allowed even to homeschool them through online courses when my kids are older. This House bill is flawed. We need to look at vaccine safety not mandating these vaccines.

Oregon Representatives are in office to protect the people and have sworn an oath to protect our constitutional rights. How is passing this bill honoring our constitutional rights of freedom of choice! If there are RISKS, and there are, then there should be a CHOICE!
I oppose this bill.

Further, according to the 1st amendment we as citizens have the right to exercise our religious rights. Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. I will add we are operating still under the 14th amendment, which states; All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and the State wherein they reside. No State shall make or enforce any law, which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

Due to our Constitutional rights, it is my God-given right to force an (NOL) Notice of Liability to all intuitions, campuses, Practitioners, and Public State representatives and or senators who support this bill. This means that if our leaders choose to pass this bill, I have the right to exercise my rights as a United States Citizen to oppose this bill with a notice of liability for any harm that will occur to myself or my family from vaccine injury allowing me to hold these parties liable for \$300 million with legal documentation if there are adverse effects from this vaccine.

Constitutional Leaders, are you willing to be held liable for vaccine injury? Do you trust the safety and efficacy of these vaccines? If there is even a question, then do not pass this bill. I feel unless our leaders and medical professionals are willing to be held liable for such injuries then we should not be mandated to inject ourselves and families with these ingredients which are in these vaccines.
