Dear Chairman Salinas and Members of the House Committee on Health Care,

I am writing in opposition to House Bill 3063 being put forth by the House Health Care Committee. There has been feigned outrage and concern regarding the MMR sparked by the media and state medical officials. Fear and propaganda are being used in an effort to create a boiling point, instigating outrage from citizens regarding children and vaccines suggested to attend school. The word "Anti-Vaxxer" is often used to brand families and their children if they are missing some vaccines, stopped vaccinating because of injury (Former-Vaxxers), or choosing not to vaccinate at all. All are lumped into one category. The government is using coercion and bullying tactics to force a medical procedure on children. Just recently, the Oregon Health Authority put out a cartoon castigating a child who was not vaccinated suggesting the child was not worthy of a Valentine.

Funny how the children are the target of public-school vaccination mandates, when in truth there are possibilities for many others not being vaccinated following the schedule now required within Oregon Schools. Teachers, staff, custodians, kitchen help, delivery people, parents, and others are not necessarily vaccinated with some or any of the vaccines that school children are required to have. Frankly, I would like to know of those representatives supporting this bill, how many of them actually are vaccinated with the vaccines that children are currently required to have. It might be beneficial to really take a look at the state capital in general and see how many possibilities there are for diseases to be passed among the staff that works there. After all, this is about herd immunity according to all of those who preach about vaccination mandates for school children. Laid out on a map this makes no logical sense. I was also wondering about an article I read in Oregon Live. This is exactly what I was pointing out. Teachers do not have to be vaccinated. I imagine because of the Teacher's Union. Here is what Representative Stonier a teacher said;

Stonier, a middle-school public school teacher, can testify that children's learning is disrupted if they must stay home. Teachers also must call in substitutes if they are unvaccinated, which interrupts lesson plans..... Oregonian Live

The representative is clearly defending a teacher's right to not vaccinate, while denying the same right for school children. Several teachers I queried about vaccinations replied that they had never been asked about their vaccination status as a job prerequisite. The Representative statement is hypocritical at best.

As an older citizen of Oregon, I am 62, I recall a much different history of disease and vaccines than the current history that is being fabricated for the unwitting ears of our youthful families. I grew up in a large Catholic family in SW Portland. I attended a Catholic grade school, I spent one year at St. Mary's high school in Portland, and my sophomore year I transferred to public high school, Andrew Jackson. When I recall the childhood diseases such as measles, mumps, chickenpox, rubella, there was no fear or quarantine other than staying home for a week. All my family, friends, neighborhood kids, school classmates, we all had these diseases and did not die. We received the Polio vaccine and that was about it. I knew all these families and their kids. Believe me, I would have known about a death from disease. I

knew about the kid that was hit by a bus and broke his leg, the boy who blew his hand off with fireworks, he ended up with hook for a hand. There was the girl that had diabetes (the only one I knew) and tragically the boy who was killed on a farm truck sitting on hay bales in the back of the truck as it went under a bridge. I recall one senior girl having cancer in high school. I had an older cousin with down syndrome and there were three families in my church who also had a down syndrome child in their later years. I had an older cousin with Polio, he was old enough to be an uncle. I had a cousin who died crossing the street on the way to school with his brothers over by Laurelhurst Park. I knew of a brother of a friend who died in the bath tub scalded to death. There was a boy in grade school who stepped on a nail and developed tetanus, he recovered. Tetanus is not communicable. I know of two boys that died in car wrecks. There was a couple of my classmates who died of drug overdose after high school, another died in a car wreck. There was a father up the street from where I live who killed all of his kids and himself. My sister in-law was hit by a drunk driver and seriously injured the other passenger was killed coming home from a college track event. My best friend's sister was killed by a drunk driver on New Year's Eve on the way home from work. My brother in-law's girlfriend was murdered by a serial killer in SW Portland. The man attended my high school and was a year older than myself. I often would notice him standing with his foot up against the lockers with a group of boys. I never would have imagined him to be a murderer. The point of my long recounting of my youth was to point out the lack of deaths from diseases.

I faced many deaths and attended a number of funerals when I was young, but no matter how hard I wrack my brain, I cannot come up with any deaths from the measles, mumps, rubella or chickenpox. I called two of my family members and asked them about their memories of these childhood diseases. My oldest brother and my youngest sister agree with me. They cannot come up with a single memory of a death from measles, mumps, rubella, or chickenpox among their wide array of acquaintance's and friends in childhood.

My mother and father grew up during the depression. Their eyewitness accounts, that I heard throughout my childhood regarding the illnesses they faced, were objective accounts. There were no vaccines. Their accounts did not even slightly reflect the measles, mumps, nor chickenpox as any of the diseases they feared. These were just the common inconveniences of life, not dreaded, but rather just part of life. On the other hand, they did talk of some diseases that they did fear. The diseases my parents feared in their youth for the most part were bacteria related such as tuberculosis, strep, and staph. There were no anti-biotics and the bacteria related illness truly could be deadly. My grandmother died of TB when my mother was just sixteen. She had been ill for years and was sent away to a Sanitarium, never to see her babies again. My mother raised her sisters, three of which developed TB. One was sent to a sanitarium to die. She did not die she recovered and lived into her 80's. I remember my mother contracting a staph infection from a rose thorn when I was young. She told me when she was young that the infection could have killed her without antibiotics. A tightknit Minnesota family my mother and her siblings all survived the depression. My mother's father lived until he died at 98. Remarkably he lived without any vaccines.

Today, things have changed dramatically. Anti-biotics once thought of as the savior of mankind, are now carefully prescribed, because of their overuse. Bacteria has become more virile and evasive, forging new pathways of infection and causing havoc for those with weakened immune system. Vaccine are now in the precarious position once held by antibiotics. Untouchable, vaccines are considered the miracle of the 20th century and the gold mind of the 21st. Vaccines manufacturers are making record profits, with

some 54 billion dollars in sales in 2018 alone. The industry is capitalizing on a product that has no liability here in the US. American's are required to use more vaccines than any other nation. With many new vaccines created in the last 30 years, pharma is readying close to 300 more vaccines to send through the pipeline to the captured public. Pharmaceutical companies are heavily lobbying our political representatives and the media spending more than any other lobbying group within the US. Pharma has also spread their roots deep within the medical establishment and universities. This tight monetary relationship makes it very difficult to extract the truth about vaccine health risks.

The dramatic increase of vaccines since the 1986 law protecting manufacturers of vaccines from lawsuits should alert any cautious law-maker to possible problems regarding safety and overuse of vaccines. There is speculation that some viruses are mutating and that vaccines are part of the reason. This is a potential disaster in the making. As with bacteria and antibiotic overuse, viruses are capable of mutations that can allow their survival. Our Children have become the testing grounds for the many new vaccines that have been brought to market in various ways. The MMR is a combined vaccine that was introduced in 1971 to the United States. Prior to that time period, the Measles, Mumps, and Rubella vaccines were standalone vaccines. The emergence of the MMR and the potential to kill three birds (and make more money) with one stone was a no brainer for Merck. It has been a controversial vaccine to this day and is surrounded by problems. Merck's own scientist have turned whistleblowers and the CDC has a scientist turned whistleblower on the MMR causing autism. These are all serious matters that many are fighting to be bring out into the open.

I witnessed my beautiful grandson harmed by vaccines. I was an unwitting participant in the early years of vaccine indoctrination. I never questioned vaccines or their safety with my own children in the 80s. Looking back now, maybe I should have done more questioning. Unfortunately, it was my first grandson's reaction that entirely changed my perspective. He was developing normally, sitting up, crawling, he walked early, he had 40 some words. Early on at five months, I noticed he was wheezing and at six months he was diagnosised with asthma. I at the time thought that this was a little odd, but asthma had become more and more common, so I did not concern myself too much. I found out after gaining my grandson's medical records that his head circumference had jumped at 6 months from the 75th to the 95th percentile. This should have been concerning to the doctor at the time in that it coincided with asthma at a very young age. A possible serious warning of reactions to vaccines.

Throughout his first year, he continues to grow and meet all his milestones. Then at 12 months, he was given a vaccine called ProQuad. ProQuad was a 4 in 1 vaccine produced by Merck and approved by the FDA in 2005. It consisted of MMR with a Varicella component (Chickenpox). The original ProQuad vaccine contained approximately 10 times the amount of varicella as the single varicella vaccine. Merck's original explanation for this was that in order for the varicella component to cause an immune response, they had to significantly increase the amount of the varicella portion of the vaccine. Sadly, this proved to be a disastrous idea for many children.

There was five-part series written about ProQuad by UPI in 2006. It was a very revealing and disturbing account of the workings behind the poor testing and shoddy collecting of data used to rush this vaccine to market. Truly, if ever a vaccine needed to be researched more thoroughly it would have been ProQuad. Rushed to market with three other vaccines, Merck was looking for a dramatic lift to their sagging stock values. The Vioxx disaster had just taken place. Merck had just admitted to knowingly killing some 60,000 people. They had lost in their court battle and things were not looking too good. So,

Merck turned to the strongly emerging vaccine department to rescue their bottom line. Four vaccines, all of which have been very controversial were rushed out to market. My grandson just had the absolute misfortune of being one of the children who received ProQuad. Merck removed the vaccine in April of 2007, three months after my grandson received it. This occurred shortly after the FDA was asked by the UPI reporter about two children's deaths in 2001 and 2002 occurring in Olympia Washington during the testing of Proquad. The deaths had not been reported by Merck to the FDA supposedly. Brought to the attention of the FDA by the UPI reporter, the FDA then did their job and removed ProQuad from the list of recommended vaccines for children.

He looked like he had a stroke. My poor grandson's face dropped, he drooled, his eyes were non-interactive and all of his childhood joy was gone. His mother complained of his persistent diarrhea, he lost his appetite. He became sicker and sicker. At fourteen months, his mother took him in to the doctor He was so sick they decided to do a blood draw. Unfortunately, the doctor's appetite to follow a ridiculous vaccine schedule provided by the CDC overcame good practice measures. The doctor without knowing the results of the blood test just taken the same day, gave my poor little grandson four more vaccines that day. And now, the story thickens.

My Grandson's health was teetering on the edge and the doctors knew it, but did not relay the information to his parents. My grandson, on the day he received those additional four vaccines had a severely compromised immune system. He had developed an absolute neutrophil count (ANC) of only 327. He had Lymphocytes of 93% and neutrophils of 3%. He was so sick. His parents should have been told, but no warning was given. In reality, he should have been hospitalized. He to this day continues to run chronic values of lymphocytes and neutrophils. There was a notice sent to his parents that their son had cancer, but as strangely as it was sent out, it was strangely taken back. Remember the parents at this time had no idea of what their son's blood condition was. No one rechecked his blood after seeing those original horrible numbers. It was essentially covered up. (probably because of malpractice concerns). This practice of overlooking key medical concerns continues.

My grandson throughout the following year is a very sick child. He has asthma. He developed Vitiligo (loss of skin pigment). He now has a positive ANA, the test used to diagnose auto immune issues and lupus. His language gradually slips away and his left eye begins an inward drift. The first doctor he sees regarding his left eye mentions a possible optic nerve problem and sends him on to a child specialist (This was only mentioned in notes not to parents). The specialist never mentions the condition again (my guess is again because this would involve further testing and questioning of his lab results, which were still not revealed to his parents). Instead, they begin treating my grandson for lazy eye.

My grandson was in reality blind in his left eye. The doctor who was the specialist ignored the warning of optic nerve damage from the previous doctor and treated my grandson for a lazy eye. This meant they dulled his good eye putting him in glasses and trying to force his damaged optic nerve to work. This essentially made him blind in both eyes. The cruelty of what these doctors did to my grandson is beyond my comprehension. When we were able to remove my grandson from the care of this well-known facility at around age 6 we went about gaining all of his medical records. His aunt, a pediatric dentist took all his records researched them herself with medical literature and was convinced that indeed he did not have a lazy eye. She set about convincing an eye specialist at OHSU to examine his eyes. He had two surgeries at OHSU that concluded that he indeed had optic nerve damage and was blind in his left

eye. He had been left to suffer for four years unable to speak, in a world of blurred vision compounded by a brain that had suffered a tremendous insult.

In addition, the Hematology doctors at OHSU concluded that there was nothing they could determine that caused his blood condition. They did many tests. Both the Casey Eye Institute and OHSU Hematology did many tests and all the tests came back with no definitive answer. This was four years after the initial blood test was done showing a unique and precarious blood condition. It was much too late to determine cause and no doctor was going to stick their neck out and suggest that the other medical group was responsible. We also did genetic testing through a renowned expert in California, and again no answers to help alleviate this child's suffering. So, my grandson lives with an unknown blood condition along with his left eye blindness, non-verbal, a positive ANA and a host of other difficulties. Unfortunately, there is still more misfortune to come.

After the surgery for his eyes at OHSU, my grandson seemed to have many headaches and be in much discomfort. He was unable to speak and let us know what was wrong. He would often shake his head in discomfort and pain. I took him to the doctors several times, but no one ever was able to figure out what the problem was. I took him to a naturopath out of desperation, she told me his ear was full of wax and to take him to a MD to have it removed. He had seen many doctors and none had said a word about the amount of wax in his ears. I promptly took him to Urgent Care. That doctor told me to take him home and remove the wax. I instead made and appointment with an Ear Nose and Throat Specialist. This doctor looks in both of his ears and pulls out two wads of identical cylinder pieces of gauze and discovers a massive infection behind the gauze. At first, I could not figure out how these two identical pieces of cylinder medical gauze got into his ears. It came to me as I lay in bed that night. I believe the gauze was used during surgery to prevent liquid from entering the ear canal. I looked it up and read a story of a man who had eye surgery and the gauze was left in his ears, to keep the fluid used to flush the eyes from draining into the ear canal. For two years my grandson lived with this gauze and pain in his ears, Two Long miserable years!

He also was hospitalized with constipation for three days about three year ago. It was horrific the treatment forcing a tube down his nose into his stomach. I would never wish this on my worst enemy.

This is my grandson's story and through it all he has become a survivor. He is learning how to communicate with a letter board. With his instructor (privately paid for), he recently wrote his goal, "heal my right good mind". Powerful words from a thirteen-year-old who has faced an onslaught of injuries from vaccines.

The use of vaccinations can be potentially very harmful for some children. There are vulnerabilities that need to be identified. Also, the protection of vaccine manufactures from law suits must end. Until, those children are identified and the companies making billions of dollars from vaccines are held responsible vaccines are a serious risk. Your child or grandchild could be the next victim. It is truly a game of Russian Roulette.

I never wanted to belong to this group of vaccine injured families. I would love to be like everyone else, blindly not knowing what hazards lay in wait with every potential vaccination of a child. I believe it is called "blissful ignorance". But I have been "WOKE" as the young now like to say and I cannot rest until vaccinations are not a money-making for-profit enterprise that are protected from law suits.

In 2007, the US government court known commonly as the Vaccine Court had 5000 cases of parents lined up to testify that their child was harmed by a vaccine and subsequently developed autism. The government dismissed all of the cases of autism being connected to vaccination on the testimony of a pediatric neurologist, who was their key witness. His name was Dr. Andrew Zimmerman. The problem was in fact, Dr. Zimmerman had changed his testimony after witnessing several children in his practice develop autism after vaccination. The government represented by two Department of Justice lawyers upon realizing that their star witness had changed his testimony, dismissed Dr. Zimmerman and then proceeded with the trial misrepresenting his testimony. The DOJ Attorney who had been told by Dr. Zimmerman of his change in opinion gave the following testimony during the Autism Omnibus Hearing:

"We know [Dr. Zimmerman's] views on the issue...There is no scientific basis for a connection" between vaccines and autism.

Recently convinced by Robert F. Kennedy Jr., Dr. Zimmerman revealed what happened in the Omnibus hearings for Autism in 2007. The following is his testimony:

On June 15, 2007, he took aside the Department of Justice---or DOJ lawyers he worked for defending vaccines in vaccine court. He told them that he discovered "exceptions in which vaccinations could cause autism." "I explained that in a subset of children, vaccine induced fever and immune stimulation did cause regressive brain disease with features of autism spectrum disorder."

Currently Robert F. Kennedy Jr. has filed a fraud complaint with the Justice Department Inspector General. Meantime the CDC has never revealed that the government expert concluded that vaccine can cause autism. Also, many of our public health officials are denying the truth of the connection. The time will come when all of those that were aware will face law suits and be forced to reveal the truth.

When Reagan signed The National Childhood Vaccine Injury Act in 1986, the government was entrusted with ensuring vaccine were safe. Since there was no more suing the manufacturers in a court of law, the government tasked the department of Health and Human Services HHS to provide the necessary safety testing. Biennially, HHS was responsible to maintain safety research for the vaccines being produced and to produce a report. A recent law suit brought and won by Robert F. Kennedy Jr. along with the act ICAN just proved that there had been no safety studies or reports ever produced in all the years since 1986.

"The result of the lawsuit is that HHS had to finally and shockingly admit that it never, not even once, submitted a single biennial report to Congress detailing the improvements in vaccine safety. This speaks volumes to the seriousness by which vaccine safety is treated at HHS and heightens the concern that HHS doesn't have a clue as to the actual safety profile of the now 29 doses, and growing, of vaccines given by one year of age.".... ICAN

ICAN along with RFK Jr. has also forced the FDA through a law suit to admit that they had allowed the flu vaccine along with the Tdap vaccine be recommended for off label use in pregnant women. There had been no study done on either of these vaccines in relationship to pregnant women. It is well known that a woman during pregnancy has a weakened immune system in order for her body to not abort a fetus as an intruder. Stimulating the immune system with vaccines could potentially cause the exact opposite effect as to what naturally is occurring during pregnancy. This is just another example of the

government allowing vaccine manufacturers a free hand without any oversight. The following is the FDA response to ICAN's request for any clinical trials done regarding these vaccines and pregnancy:

"These requests sought the clinical trials relied upon by the FDA prior to approving any currently licensed influenza or Tdap vaccine for use in pregnant women as an indicated use. ... We have no records responsive to your requests."

How can there be mandates when this is the truth regarding the safety measures used in the US. I have told the story of my grandson to open minds to the pain and suffering he has endured. I hope that my representatives of Oregon would not believe the pharmaceutical companies along with the pharma captured departments of our government over the thousands and thousands of parents pleading the same story. We are being ostracized and stigmatized by the very companies that caused the injuries. And sadly, many of our representatives are believing the companies that stand to make billions off of the injured children. The numbers of ill children just keep growing including Autism, cancer, ADHD, Tics, Allergies, Asthma, Eczema, narcolepsy, seizures, and on and on. The children of this generation are very ill. The gate keepers of our children's health, doctors, the CDC, HHS, the FDA have opened the gates to allow the purveyors of illness to have free reign. When the truth comes out and it will, I would hope you are on the right side of history. This is one of the worst disasters ever perpetrated on the children of this country.

I have not even at this point brought up the subjects involving crimes and fraud perpetrated by Merck and the CDC. First there are the two former Merck employees turned whistleblowers, they have filed a lawsuit regarding the Mumps portion of the MMR. The lawsuit is still in court. Second, there is the CDC Whistleblower, Dr. William Thompson. He gave the government 10,000 documents showing that the CDC covered up the connection between the MMR and autism where black baby boys showed a significantly higher risk for autism when given that vaccine before the age of 3 (my grandson is half black). To date the government has not called on Thompson to testify. Thirdly and important to note, a CDC researcher named Dr. Poul Thorsen is on the federal governments most wanted list for stealing close to two million dollars from the CDC. He has been indicted on 22 counts of money laundering and fraud. Poul Thorson who is hiding in broad daylight in Denmark and has been waiting to be brought to justice since 2012. He just happens to be the main researchers for the CDC proving the MMR is safe! Finally, there is the group identified as SPIDER (CDC Scientists Preserving Integrity, Diligence and Ethics in Research). Here is a brief part of their letter written to the CDC.

"We are a group of scientists at CDC that are very concerned about the current state of ethics at our agency. It appears that our mission is being influenced and (CDC Scientists Preserving Integrity, Diligence and Ethics in Research) shaped by outside parties and rogue interests. It seems that our mission and Congressional intent for our agency is being circumvented by some of our leaders. What concerns us most, is that it is becoming the norm and not the rare exception. Some senior management officials at CDC are clearly aware and even condone these behaviors. Others see it and turn the other way. Some staff are intimidated and pressed to do things they know are not right. We have representatives from across the agency that witness this unacceptable behavior. It occurs at all levels and in all of our respective units. These questionable and unethical practices threaten to undermine our credibility and reputation as a trusted leader in public health. We would like to see high ethical standards and thoughtful, responsible management restored at CDC."

I have one more thought which I believe should be mentioned. Robert F. Kennedy Jr. has become a beacon of hope regarding vaccine injured children. I remember his father coming to Oregon in 1968. At the time I was young, but I can remember my parents and how they admired him. In 2015 Robert F. Kennedy Jr. came to speak regarding the mandating of vaccines with SB442. He invited all of Oregon's senators and representatives to come and listen to what he had to say. Only two or three showed up. I went and met him and felt privileged to be near such a man. Like his father, RFK Jr. is speaking out to help those who have been marginalized and maligned for telling the truth about their children's vaccine injuries. With nothing to gain other than criticism from the industry and naysayers, he has taken on the pharmaceuticals vaccine manufactures. Pharma is the most influential and powerful lobby in the US, far outspending every other lobby in the country.

Robert F. Kennedy Jr. along with several other law firms all chomping at the bit, just won a gigantic law suit against Monsanto and their product Roundup that contains glyphosate. It has been shown that glyphosate causes certain cancers. This was the first law suit to ever win against Monsanto! They won by revealing the deep underlying lies in company emails and inner company memo's acknowledging their knowledge of cancer causation with their product Roundup. Bayer just bought Monsanto and is now facing thousands of law suit for cancer and Bayer's stock has taken a substantial hit.

Now RFK Jr. has turned his sights on Merck. Currently, he has brought a lawsuit against Merck for the HPV vaccine (one of the four Merck vaccines with ProQuad that I mentioned earlier in this letter) and he has been allowed to proceed with discovery. This is a very big deal! He will win against Merck. Law suits have this lovely way of forcing emails and memos out into the light of day. Knowing this, I would think you might want to listen to what Robert F. Kennedy Jr. has to say about vaccine safety. He is not an opponent that should be looked at as a light wait.

His father, Senator Robert F. Kennedy Sr. gave a speech about apartheid in South Africa in 1966. It was called "Ripple of Hope" and it was considered to be his greatest speech by many. Here is a quote from that speech;

"Each time a man stands up for an ideal, or acts to improve the lot of others, or strikes out against injustice, he sends forth a tiny ripple of hope, and crossing each other from a million different centers of energy and daring those ripples build a current which can sweep down the mightiest walls of oppression and resistance."

This is why his son is fighting for us. He has researched, investigated, and studied this issue upside and down, inside and out. Once impervious to this cause, Robert F. Kennedy Jr. now knows and has stepped up to head a battle for justice. He is a man of ideals and a fighter for justice. He will not rest just like his father;

"who saw wrong and tried to right it, saw suffering and tried to heal it" Ted Kennedy at Robert Kennedy's funeral.

I am fighting so that the wrong that was done to my grandson is righted. This cannot happen when legislative bodies continue to support vaccine manufactures disregarding the children that have become the fodder of the vaccine war on disease.
