

I am writing in opposition of HB 3063.

Very briefly, this is what I would like you to know about vaccines:

1. **Vaccine Ingredients:** MMR vaccines contain DNA fragments from WI-38 and **MRC-5 cell strains**, which are derived from aborted human fetal tissue. In other words, aborted human fetuses have been used in the development and manufacture of some vaccines. Monkey and dog kidney cells, fetal cow serum, and chicken embryos are also used in the manufacture of vaccines. Pig virus DNA has been detected in rotavirus vaccines. I hope you can see how this might be problematic for anyone who is pro-life (against abortion), various religious groups, some ethnic groups (in India, cows are consider sacred animals), vegans and vegetarians, libertarians, and anyone who values informed consent and freedom of choice regarding medical interventions.
2. **Vaccine Doses:** In 1983, U.S. children received 24 doses of vaccines. Today, children are recommended 69+ doses of vaccines.
3. **Vaccine Liability:** The 1986 National Childhood Vaccine Injury Act made it so that vaccine manufacturers could no longer be sued for vaccine injuries. As such, there is no financial incentive for vaccine manufacturers to create a safer product.
4. **Vaccine Injury Compensation:** Since 1988, the National Vaccine Injury Compensation Program has paid over \$4 billion in taxpayer dollars for vaccine injuries (vaccine manufacturers, and not taxpayers, should be paying for vaccine injuries).
5. **Vaccine Adverse Events:** Less than 1% of vaccine adverse events are reported to the Vaccine Adverse Event Reporting System (VAERS), so we have no idea as to the full extent of injuries and death caused by vaccines.
6. **Vaccine Safety Studies:** Other vaccines, or aluminum adjuvant (which is a known neurotoxin), are routinely used instead of an inert placebo in vaccine safety studies. In other words, properly designed safety studies have not been conducted.

7. **Scientific Fraud:** William Thompson, a senior CDC scientist, came out as a whistleblower stating the CDC omitted and destroyed data showing an association between MMR vaccine and autism in African-American boys. This is a clear manifestation of institutional racism.
8. **Conflicts of Interest:** The CDC holds dozens of vaccine patents despite being the federal agency that adds vaccines to the recommended schedule.
9. **Vaccinated vs Unvaccinated Studies:** The only U.S. study that has been done comparing health outcomes of completely unvaccinated to fully vaccinated children, found that fully vaccinated children had a 4-fold increased risk of developing ADHD and Autism Spectrum Disorder (ASD).
10. **Informed Consent:** There are potential risks and benefits associated with any medical intervention and vaccines are no exception. Please maintain freedom of choice regarding medical decisions and protect patient rights to informed consent.
