House Committee on Education Testimony in Support of HB 2023 March 11, 2019, 3 pm, Hearing Room D

Chair Doherty, Vice Chairs Alonso León and Helt, and Representatives Hernandez, Neron, Reardon, Reschke, Sollman, and Wallan:

For the record, I am Dr. Joseph Gallegos, I am a professor of social work with over forty years of experience in higher education and a former school social worker. I am a member and long-time supporter of the Oregon Commission on Hispanic Affairs. I am here today for the Chairs of the four Advocacy Commissions representing our support for HB 2023 relating to the importance of ethnic studies to Oregon's success.

The Oregon Commissions on Asian and Pacific Islander Affairs, Black Affairs, Hispanic Affairs and Commission for Women all support HB 2023 that will establish, in collaboration with the Oregon Department of Education, an Inclusive Educational bill (Ethnic Studies 2.0) which is the next step in creating greater visibility of the experiences of all students in Oregon. What this bill does is to direct the SBE to add inclusive textbooks and instructional materials into existing social studies for K-12, allowing students to see themselves in the story of our state and country. HB2023 will ensure that social studies standards will include some instruction on the contributions of Native Americans; those who are of African, Asian, Pacific Island, Chicano, Latino, or Middle Eastern Descent; are Women; as well as those with Disabilities; those who are immigrants or refugees; or those who are lesbian, gay, bisexual, or transgender.

One needs look no further than the Oregon state song, adopted in 1920, to be reminded of the state history steeped in racism and exclusion. This bill will reverse the teaching of that history and lead to a celebration of our state's diversity. Many past commissioners, and current members, have highlighted the need for public school education across the state to include ethnic and social groups with the widest cultural lens in their educational
