RECOMMENDATION 1

Congress dedicate up to \$1.3 billion annually in existing revenue from the development of energy and mineral resources on federal lands and waters to the Wildlife Conservation Restoration Program (16 U.S.C. 669b(a)).

- Dedicates \$1.3 billion annually in existing revenue from the development of energy and mineral resources on federal lands and waters to the Wildlife Conservation Restoration Program
- Oregon's apportionment of the funds would be approximately \$52 million biennially
- Requires a 25% non-federal match contribution (\$17 million biennially)
