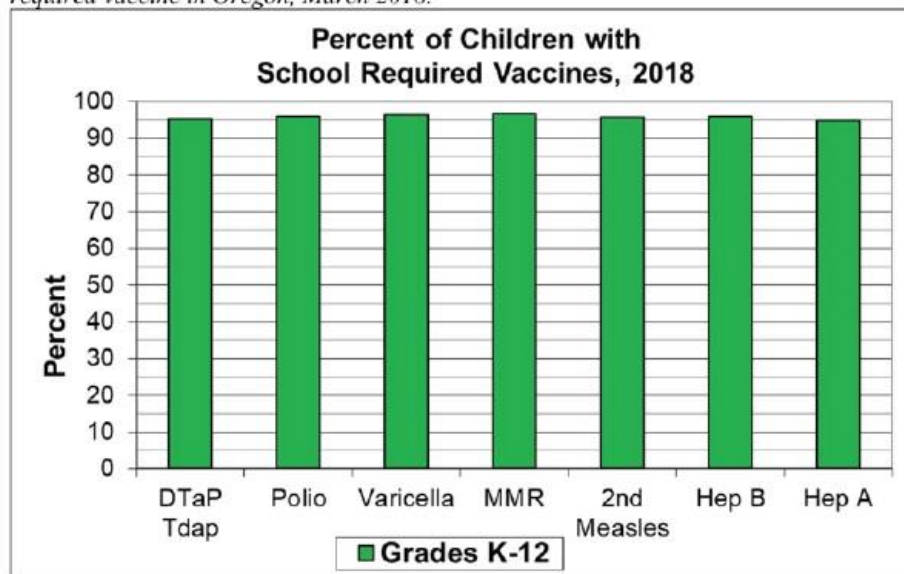

Figure 1. Percent of children in kindergarten through 12th grade complete for each school-required vaccine in Oregon, March 2018.

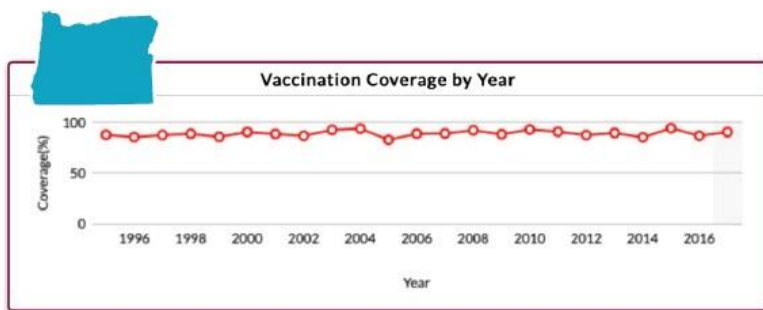

In fact, in 2018 alone, there have been more reported deaths from the MMR vaccine, then from actual measles since 2003, in the USA. Additionally, most vaccine package inserts state in **section 13.1** that "*Carcinogenic potential, mutagenic potential, or impairment of fertility have not been evaluated*"².

The Hippocratic Oath and the Nuremberg Code cannot be ignored! This bill is unethical, holding a child's education hostage in exchange for a medical procedure, and **WE DO NOT CONSENT**. Willful ignorance, in an age of knowledge readily available at your fingertips, is a choice, and any legislator who
