## Good afternoon Committee,

I'm writing to ask for your help in fighting against HB 3063. I am one of your constituents from Hillsboro. Thank you for taking time to read my email.

As I'm sure you're aware, there is a committee set to meet tomorrow regarding HB 3063 to forcibly mandate every child is vaccinated in order to receive his/her right to education. These are scary times for families like mine. I'd like to tell you my story and how this bill could affect us.

We adopted my sweet son Mason birth so have a very small and limited medical background on him. We followed our pediatricians delayed schedule, but around 12 months Mason received his DTAP and HIB vaccines together. Went happened the next hour decided once and for all that vaccinations were not a safe choice for our family. My son who NEVER falls asleep in the car passed out and I couldn't wake him easily when we got home. He was lethargic and limp. Keep in mind my little guy never stops moving, even with a cold he never slows down. So this was especially scary. He spiked a fever of 104 and we rushed him to urgent care where we were told 'this is normal' and to just go home and wait. It took several days of fighting but finally I got my sweet boy back. But this experience was terrifying enough that we worked with our pediatrician to determine my son is one of the children that vaccines ARE NOT SAFE FOR.

Under bill HB 3063, would Mason qualify for a medical exemption? No. His reaction was not severe enough. So even though we are under the care of a physician, we still wouldn't quality. Not until he gets a severe enough reaction that his life would be in jeopardy. Then he MAYBE could qualify.

I AM UNWILLING TO RISK HIS LIFE!!!! This is a mothers job! To fight for her child. HB 3063 completely removes my ability to do so if I want my son to receive his right to education.

Here's how HB 3063 could negatively affect us:

- My son could receive all his vaccines to get up to date and have a severe reaction, possibly death as stated in every vaccine insert in the package as a listed and known potential side effect
- We could be forced to home school and take one parent away from the ability to earn income.
- We would not be allowed to attend our church possibly because there is a private school housed there
- We would deeply consider moving to another state or country where medical freedom is allowed (taking away taxes from the state of Oregon)
- We would be ostracized from our community

And so many more ways this would negatively affect our family and 1000's more.

Do you know that people like me are being villainized on every social media platform and in the news? Do you know that I have to endure dirty looks, lost relationships, death threats, people wishing death or sickness on my son, being repressed and silenced on Facebook, Etsy, Pinterest, Amazon and every news media article surrounding this topic? Do you know that mother's like me are constantly misquoted in interviews and articles? Do you know how much it hurts to have family members call me names? All because I want to do what's best and safest for my son. Ask yourself – why is this people group being so violently discriminated against? Ask yourself – who is trying to silence these parents? WHY WONT

ANYONE BELIEVE US? Why would we fight so hard against something unless there was truth to what we've discovered?

We are not a danger to society. My son is the healthiest child. Never one ear infection, food allergy, not so much as one case of the flu. If he has a cold, we stay home until he's not contagious. Mother's like me are well educated and researched and are passionate about keeping kids healthy. We do daily work to build our children's immune systems. We're not 'anti vaxxers' that are selfishly hoping to endanger the world.

I appeal to you – stand up for women like me who are being repressed. Stand up for son's like mine who trust their parents to protect them. Stand up for the innocent and voiceless. Stand up for the numerous mothers who just BURIED THEIR BABIES because they trusted the CDC schedule and allowed their child to be filled full of aluminum, formaldehyde, aborted fetus cells, animal dna and cells and other fillers/additives that the FDA would never allow us to consume in any other arena. Stand against medical tyranny.

Please I beg you. Help us fight against HB 3063. Our children's lives and educations depend on it.
