It may be too late to submit testimony but I will do so anyway hoping to still be heard.

I have 4 sons, 3 of which have Autism, which is not supposed to be statistically possible. Except for the fact that it happened. We have a family history of autoimmune disorders like Hashimoto's and type 1 diabetes. People with a Family history like this should be exempted and this should be added to the Bill. We are an at risk group and need protection via herd immunity just like kids undergoing chemo and other kinds of medical exemptions, as well as family history based exemptions.

We moved from California to Oregon to ensure our 4th son was not exposed to the same risk our other 3 sons were. The 3 that have autism got it after their MMR shots. MMR although not a direct cause of Autism is implicated in new evidence not Dr. Wakefield related, its new evidence that stands on its own. It shows MMR activates MCP-1, which summons macrophages onto the scene. If Aluminum Adjuvant was given in previous vaccinations the MCP-1 can scavenge this form of aluminum from the body, particularly the nanoparticulate form of Aluminum, then shuttle it across the blood brain barrier. New studies are showing that brains of Autistic people are loaded with Aluminum, on the level found in those with Familial Alzheimer's, which was upwards of 30-40 PPM. This is massive. [Normal brains might have 1 PPM not 30-40PPM!!!] Other research shows when you directly inject the nanoparticulate form of Aluminum into rats they develop Autistic like symptoms as well as symptoms of Alzheimer's. The CDC\FDA have NOT done research of this form of aluminum, but only on two forms that do NOT cross the blood brain barrier, i.e. the ionic and citrate forms. What's more is their tests were not done on brains still in development which is also crucial. Their safety tests are therefore invalid, they did an apples to oranges comparison. They need to test the nanoparticulate form of aluminum on brains still in development until then they can not claim aluminum adjuvant is safe! There are NO\ZERO studies demonstrating aluminum adjuvant [the nanoparticulate form of Aluminum] safety, yet we carry on as though it's been shown safe. This is absurd. Only a no Vote on HB3063 is Moral.

Also since the introduction of mandated vaccines in California the Autism rates have skyrocketed in Lock Step. We have to err on the side of caution with this, so I must URGE a NO vote on HB3063. I have sent emails to my representative and senator with links to the new peer reviewed studies demonstrating the validity of what I have stated above. These are well established newer studies. I am a citizen of Oregon in the Portland area.

Again, please add at risk Families to the exemptions group in case this Bill passes into law, which would be draconian. But based on Autism rates in California and the lack of safety for Aluminum Adjuvant Bill HB3063 must not pass. I implore you VOTE NO on HB3063!!!
