

Dear Education Committee Members,

Please examine the following 64 letters that were sent to various school boards arguing against the use of wi-fi and cell towers in schools. These were all written by scientists, doctors and health researchers, studying the biological effects of microwave radiation on living cells. Children are the most susceptible to harm.

Please consider that these experts do scientific studies, read scientific studies, see patients and live with relevant information and are not influenced by social pressure, industry money or cultural memes that promote the use of wireless devices in schools.

Unfortunately in our system, where profit overrides consideration of human life, it is politicians, bureaucrats and lobbyists that make decisions about the use of potentially dangerous devices without input from the science community that could better inform whether certain products are safe or not. Cell phones, wireless routers, smart boards, cordless phones and other wireless devices were never pre-market safety tested.

A study was done by Dr. Henry Lai of Washington University. Dr. Lai examined the results of cell phone studies documenting biological effects and found that results depended on who funded the study. Here are his results presented at Lakehead University in Thunder Bay Ontario on February 22, 2010: Industry funded studies found no harm in 72% of the studies while the reverse was true for independently funded studies.
