## **BottleDrop locations are only for return of containers purchased in Oregon**

- Oregon Bottle Bill (ORS 459A.710), supported by Oregon Liquor Control Commission Administrative Rule (845-020-0035), states that a dealer (grocery store or BottleDrop) is not required to accept an empty beverage container if the dealer has reasonable grounds to believe the container was sold at retail outside Oregon.
- Effective May 1, 2015, BottleDrop redemption centers will refuse to accept containers from individuals with Washington license plates who cannot reasonably substantiate the Oregon origination of their containers.
- Beginning May 1, 2015, Washington residents should recycle using curbside programs or return containers to the locations below:
