I am writing in support of HB 2516 prohibiting State School Fund monies for virtual charter promotion. As a parent of three children in Salem-Keizer School District, I am concerned about virtual charter school lack of accountability, increased inequality and failure to educate Oregon students.

Oregon's State School Fund distributed about \$60 million to school districts sponsoring virtual charter schools for the 2015-16 school year. Oregon Connections Academy spent \$200,000 on promotional ads in 2015-16 alone, said Allison Galvin, ORCA's executive director.*

These schools have consistently failed statewide assessment participation and proficiency rates.
