

Dear Chairman Salinas,

I am writing now to plead with you not to support House Bill 3063. This Bill will segregate an entire population in Oregon. You are not only going to be segregating children from educational rights, but you are going to be segregating children of color.

My grandchildren are half black. They live in Sherwood. You will be setting them up to be ostracized, not only because of vaccines, but also because they are black. They already face the difference of their skin color in a town that is predominantly white. Now you will add not being able to attend school. They live in affluent neighborhoods where children of color are not common in Oregon. This could easily add to bullying not openly related to race but rooted there.

My oldest grandson was harmed by a vaccine that was taken off the market two months after he received it. It is called ProQuad, a 4 in 1 vaccine containing MMR with Varicella. He looked like a stroke victim. This vaccine has a horrible history that I could go into, but is easily researched on the internet. He went blind in his left, developed chronic neutropenia and lymphocytosis, a positive ANA, Vitiligo, lost all of his language, and diarrhea followed by constipation. His father has to pay for a nanny that is his constant companion when he is not in school.

The CDC Whistle blower, Dr. William Thompson, has implicated the MMR vaccine causing autism. He provided some 10,000 documents to Representative Posey from Florida and met with him and yet there has been no hearing on the matter. Dr. Thompson identified a significant 340% increased risk for black males if given that vaccine under three years of age for developing autism. He eventually moved back to Sherwood with my encouragement. His son was sent out of Sherwood schools because of behavior issues and now has a 45-minute ride to and from school every day. Just in the last few months he has had major improvements and is having some success in

school. And now after all of this hardship this government has the audacity to take away the little this child has gained. You are willing to inflict further pain on a family reeling from way too much suffering already.

All of my children are scientists. None of these adults feel that the vaccine schedule in Oregon needs to be dictated by the government. All have a deep understanding of science. They all witnessed what happened to my grandson forcing our whole family to take a deep look at what is going on in this country since the 1986 federal act to protect vaccine manufactures.

Autism number in Oregon continue to rise. The numbers for boys being diagnosed is 1 in 24. The numbers of deaths related to autism continue to rise. Children with autism are 40 times more likely to die from injury than a neurotypical child. The average life expectancy is 36 years. The real emergency in this state is Autism.

The science currently being used by the CDC is tobacco science. Repeatedly the US government stood by tobacco manufactures as it became very apparent tobacco caused lung cancer. Tobacco was once what Pharma is now, the most powerful lobby in the US. The truth was being told over and over again, but the government stood blindly by the Tobacco manufactures until the lie became impossible to cover up. Re: *Aluminum Adjuvants*

Dear Directors:

I am writing to you in regard to aluminum adjuvants in vaccines. This subject is one my laboratory works on intensively and therefore one where I feel that I have some expertise. In particular, we have studied the impact of aluminum adjuvants in animal models of neurological disease, including autism spectrum disorder (ASD). Our relevant studies on the general topic of aluminum neurotoxicity in general and specifically in regard to adjuvants are cited below.

These studies and the broader existing literature regarding aluminum toxicity, lead almost invariably to the conclusion that aluminum in any chemical form is always neurotoxic when administered to humans. Further, I am convinced that aluminum adjuvants in vaccines may contribute to neurological disorders across the lifespan. In adults, such adjuvant may induce macrophagic myofasciitis, a disease with neuropathological aspects. In children, there is growing evidence that aluminum adjuvants may disrupt developmental processes in the central nervous system and therefore contribute to ASD in susceptible children.

Despite the foregoing, the safety of aluminum adjuvants in vaccines has not been properly studied in humans even though, pursuant to the recommended vaccine schedule published by the Centers for Disease Control (CDC), a baby may be injected with up to 3,675 micrograms of aluminum adjuvant by six months of age.

In regard to the above, it is my belief that the CDC's claim on its website that "Vaccines Do Not Cause Autism" is wholly unsupported. Given this, I remain convinced that much more research on the role of aluminum adjuvant in vaccines and neurological disorders, including ASD, is warranted and should be a research priority for the NIH and other funding bodies.

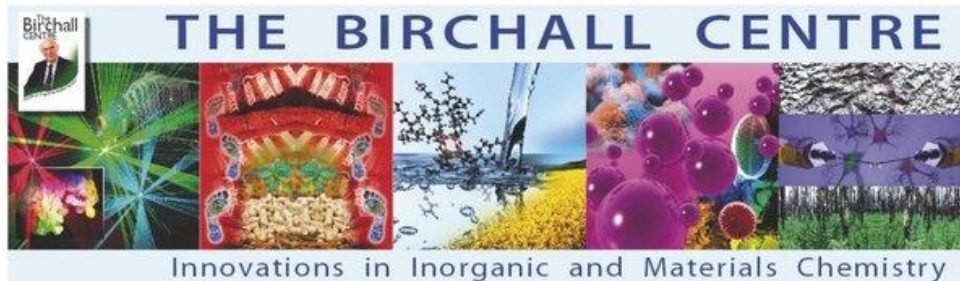
