Dear Healthcare Committee Members,

My name is Veronica Darling. No doubt your staffers and aides have heard from me many many times in the last month or so. I have also been by each of your offices in Salem, once on the morning of the hearing for HB3063 to hand deliver our typed out testimonies and once to hand deliver flowers to you in the hopes that you would acknowledge that vaccine Injury is real.

You have already heard my concerns about how this legislation will impede informed consent, how I believe it will deny over 30,000 children their right to a Free and Appropriate Public Education. You've heard how this measure is a violation of IDEA. You've heard that teachers will be laid off because of shrinking classroom sizes. You've know that there are vaccine manufacturer whistleblowers waiting to be deposed before Congress. You're aware that this bill will lead to much financial hardship for middle class families. You've seen the data that our herd immunity rates are excellent. You know the Vaccine Module System is already working. I'm sure you're aware that there is no actual health crisis due to the fact that we are literally not experiencing a health crisis in Oregon. So, what else can I share with you that would give you pause enough to vote NO on HB3063?

All I can share is my son's story and the ways these vaccine mandates will impact my family.

We moved here from CA 3 years ago following the vaccine mandates in CA(SB277). I am a mother of 4 children. We have 4 children and are currently foster parents of 3 more. They all range from 5 to 13 in age currently. My oldest son Connor, for whom I left a flower in your vase, has a genetic predisposition to Vaccine Injury. He was fully vaccinated on schedule per CDC and AAP guidelines. Post vaccination(every time) he would get a high fever, an unnaturally high pitched scream, double ear infections, and asthma attacks. We would then have to have him on fever reducers(both acetaminophen and ibuprofen) around the clock, prednisone, an inhaler, antibiotics and a nebulizer for weeks. He did not meet his milestones in a timely manner and was found to be more and more delayed after each vaccination. Finally at age 5, after having received all of his required immunizations for kindergarten, his pediatrician, in search of the reason as to why he was responding so poorly to injections, had him tested for genetic mutations relating to his ability to methylate and remove toxins from his body. What we found is that Connor, and children like him, cannot swiftly clean his system of the adjuvants in vaccines. They were pooling in his brain and causing inflammation. He was diagnosed with Austin's Spectrum Disorders at 7. He was also diagnosed with Sensory Processing Disorder, Anxiety, OCD, and depression. I tell you this so you will understand my heatitancy to vaccinate fully and on schedule. Therefore, HB363 will leave my family no choice but to leave Oregon. I will not be swayed in my decision to prioritize informed consent. As we leave the state, you will be traumatizing my own 4 children and our 3 foster children further. We are currently waiting to hear if we can adopt these kiddos. But, there is no way for me to homeschool my kids and provide for them the type of education they deserve while I am also being the type of dedicated foster mother that I have been. I use the time all of my kids are at school to facilitate visitation for my foster children, to drive them to their many doctors appointments or therapies. I use that time to have meetings with their case workers and lawyers and CASA. I use the time that they are at school to connect with my support team and network, who give me the help and stamina I need in my role as Foster Mom. Without that crucial time I will no longer be able to fulfill my duties and as such, the three children I have been loving so well will be forced to leave our home. Where will they go? We became foster parents and opened our home to keep them out of a hotel with a social worker because there are no extra homes available. What steps are in place t catch the children who will become collateral damage in your efforts to punish parents who are "non compliant" with your Big Pharm Lobbyists agendas. The scope and fall out of this legislation is far reaching. Please consider all of this as you prepare for your work session tomorrow. My family is not unique. There are so many of us out here and all we want is the freedom to continue living peacefully as we have been doing, working and contributing to this place we love so much. HB3063 is not the right legislation for Oregonians.

Please oppose.
