Ask ANY coach or ANY principal at ANY Middle- or High school in Oregon to confirm this. This is an epidemic in the making.

It is already costing Colleges money. COCC in Bend had to hire a drug counselor to "advise" College students on the dangers of using THC or CBD in any form and getting addicted and dropping out, or getting bad grades. Do you seriously believe that retailers of these products bother with legality, especially when we already have 6 1/2 years of overproduction in Oregon as of the last count (Jan 2019) and we already have a "public" track record of compliance like this? Unlikely. Strict oversight is EXTREMELY important.

Another reason for oversight is the toxicity of the products. Pesticides, herbicides, miticides, and fungicides on mariuana are completely unregulated - because the government cannot make any rules because the whole plant is federally illegal - why make rules for something you don't allow in the first place? What do diseases and bugs on plants love? Greenhouses - a warm, moist, well fed environment with plants that grow like "weeds". Mildew, aphids, spider mites, and leaf curl LOVE these kinds of environments and many pot growers do not know (or care) what they put on these plants. Look at reports from Oregon and surrounding states where inspectors had to pull up to 25% of product off the shelves because it was TOXIC - not fit for human consumption. There are articles of pesticides that the growers use where a half teaspoon can kill a bear. Again, oversight is ETREMELY important.
