Of that total 1897, 83%, were suicides. 53, 2% were by police action, 25, 1%, were considered accidental and the last category, homicide numbered 282, 12%. Certainly, once again we can all agree 282 homicides is a terrible number but not impressive on a statistical basis compared to suicides. So, do we have a gun problem or a mental health and social problem which is were our attention should be.

The first murder I ever read about took place in the book of Genesis, in the Bible, when Cain killed his brother Able in anger and jealousy... with a rock. Given the current legislative logic, we should outlaw rocks (I am not being humorous here).

If you continue to read from the Oregon.gov page you will find in those above numbers regarding homicides these statistics: of those who committed the homicides 44% were in a depressed mood, 33% had been diagnosed with mental illness, 27% were under treatment for mental illness and 13% had themselves had suicidal thoughts. As much as you want to talk about your life saving laws and believe what you yourselves say, to the contrary, our own state reported statistics do not support the idea that we have a gun problem. Not safe zones but killing zones. Every mass shooting in the US, with the exception of the atrocity of Las Vegas, was in a gun free zone.
