For the unknowing, the confused, the misinformed, and the free. I am typing this letter as I am not able to make the April 2nd 2019 assembly in Salem, Oregon. I am a music teacher, a volunteer, a father, a husband, a son of 2 long standing Oregonians. I am an eldest brother, a Veteran and most important, a law abiding concerned citizen living in a State that I swore at the age of sixteen to protect against all enemies, foreign & domestic.

The bill that is currently being determined on whether to become multiple laws in the State I live is concerning for a number of reasons. Though I understand the intents and the "well meaning" of all the representatives involved, including children (ages 16 and under). However what I see being pushed forward and quite literally down the throats of all Oregonians is that we aren't able to be safe, law abiding citizens without the involvement of the government. Namely the same representatives whom are constantly trying to strip our state, it's residents and more specifically myself and the people I swore to teach, inform, and protect until my last breath of our inalienable rights that not only we born with. I also have earned through service and dedication to the country I love and have loved since I was 16 and raised my right hand in defense of.

To allow any of the following requests, "propositions" you may call them into law is not only damaging to the 1st Amendment, but also the 2nd in a number of ways;

In reference to gun stores, as an entity that has any control over any citizens Constitutional Rights is absurd. Furthermore, firearm dealers, "gun stores" as it's stated are all businesses ran by people. People who make mistakes, people whom once handed power can and may abuse said power. IE. Telling any law abiding citizen that they can or can't purchase or be involved with something that is a born right.
