\$6,600,000 General Fund to DHS supports implementation of the federal Family First Prevention Services Act (FFPSA), including funding of in-home services. Under FFPSA, Title IV-E Federal funds can be used for prevention services for the first time, for children who are designated 'candidates for foster care' by DHS Child Welfare. Cost for the program includes one two Operations and Policy Analyst 3 positions to help carry out chosen interventions. Special payments reflect the cost of contracting for the intervention in communities.

• \$3,500,000 General Fund to DHS to support therapeutic foster care. DHS projects that this amount would fund therapeutic foster care for 169 children, assuming each individual receives services for 270 days at a cost of \$146.60 a day. The funding also pays \$1.84 million for 20 contracted therapy teams to assist the foster youth and therapeutic foster care parents. The Other Funds represents funding from Children's Trust accounts, child support and SSI/SSDI benefits which are used to reimburse the state for the child's cost of care. The 2019-21 DHS Governor's Budget Policy Package 090 also includes this investment.

The \$8,400,000 General Fund appropriation to supplement existing programs including enhanced services for children with intellectual or developmental disabilities who may also have behavioral health needs aligns with the Governor's Budget Policy Package 129 which includes \$8,477,001 General Fund with a Federal Funds expenditure limitation of \$17,002,265, and 11 positions (7.52 FTE) to support specific services to children in order to address the crisis in access to services.

- \$6,600,000 General Fund to OHA to support intensive in-home services for children with behavioral health needs. The 2019-21 OHA Governor's Budget Policy Package 403 includes \$6,575,316 General Fund and a Federal limitation amount of \$13,064,484 to create and expand intensive community-based behavioral health care for Oregon children. Approximately 1,500 youth age 0-18 will receive Medicaid-funded services in their home communities. The costs are offset by an estimated 300 youth who will avoid costly psychiatric residential care when these community-based services are available.
- \$3,076,000 to OHA for statewide implementation of crisis and transition services. Currently OHA provides a program at seven sites that are partnering with six hospitals. With funding from this bill, OHA will add another five sites making the resources available to more hospitals.

This measure requires budgetary action for the allocation of General Fund resources and position establishment.
