However, the health of our community's sole water supply is under threat with the clear cut planned by Stimson Lumber along Short Creek. The creek is in a vulnerable steep canyon that already regularly closes in heavy rains right now while fully forested. Under current regulations, Stimson has the right to clear cut close to the creek, and use any number of chemicals and herbicides including Round-up, linked to Parkinson's disease (OPB report 3/15/19). To date, no analysis has been done by Stimson on the impact of the planned work to develop a strategy to protect the health of the creek and Oceanside's water supply. By law, none is required.

What protections do we have as residents and citizens to safe drinking water? How can we know that the water will be protected without an analysis of what is needed to ensure protection? Isn't this is the role of government, to ensure the safety and welfare of it citizens?

We also support the economic health of the community and the state, which the forest industry is integral. When we first came to Oregon, we were shocked at the logging methods.
