The real problem that needs to be addressed is drug and alcohol abuse, mental illness, and a general sense of human morality. Why now, are we having these outbreaks of violence? The rallies in downtown Portland where groups are seizing control of roadways and streets, yelling profanity at innocent drivers and pedestrians, causing property damage and personal harm to others. Criminals tend not to obey laws, for example, murder is against the law. It will take away family activities such as trap and varmint shooting while teaching the next generation gun safety and proper use of a firearm. It will take away the right of a rancher to protect their stock causing financial harm in Oregon's Agriculture Industry. I think you will be surprised, or already know, that legal gun owners are not the ones conducting mass shootings or person to person violence such as gang shootings. Those gun owners never went to a store and got a criminal background check. They never went to the Sheriff's office and completed the application for a concealed handgun permit. They bought these guns off the street through the black market. Guns are not your problem, availability of illegal weapons and the lack of value for human life are your problems. Don't punish law abiding citizens and make them criminals because you, as lawmakers can't figure out how to get the illegal guns out of the hands of criminals. These gun control bills are a farce and political propaganda to make it look like law makers are trying to fix gun violence, yet all these bills do are make the law-abiding people you represent criminals and victims. Look at how strict gun control laws have worked in Chicago, Illinois. Gangs are out of control, or rather in control of the entire city. Gun violence in the "Gun Free" zone of Chicago has increased by 800% since 2013, 540 people were murdered in 2018. In the month and half of 2019 there have already been 25 people killed by guns in Chicago.
