Dear Chairman Barker and Members of the Business and Labor Committee:

We, the undersigned employees of CDK Global, are writing to you today to voice our opposition to House Bill 3152.

CDK is one of the country's leading firms offering state-of-the art enterprise software known as dealer management systems (DMS) and related services to auto, truck, motorcycle, marine, recreational vehicle, and heavy equipment dealerships. CDK's DMS offerings provide dealers with proprietary software tools and resources necessary to manage core aspects of their business.

We have over 400 employees in our Portland office, and we are responsible for developing and maintaining the software that comprises our DMS. At CDK generally, and in Portland specifically, we take security very seriously.

House Bill 3152 would require us to open our "virtual doors" to any third party that an automobile dealer chooses, regardless of their intent, security protocols or adherence to secure system standards. This requirement would cause havoc in an otherwise strictly-controlled enterprise network and create systemic risk that significantly increases the likelihood of data breaches.

As a software developer, the prospect of creating thousands of new access points to our system is a cybersecurity nightmare. Each access point represents a potential area for a breach, and one breach through an unknown third-party could be all that it takes to overwhelm our system.

As Oregon consumers, this bill is alarming on a personal level. We purchase and finance our cars in Oregon. We service our cars in Oregon. House Bill 3152 makes the personal data we provide dealerships less secure, and that is of grave concern to us.

That is why we oppose House Bill 3152 and urge you to oppose the measure as well. House Bill 3152 will undermine our efforts to provide a secure system that is a part of our nation's Critical National Infrastructure.
