Measure Description:

Directs professional licensing boards to develop pathways to licensure, certification or other authorization to practice occupation or profession for specified persons.

Summary of Fiscal Impact:

Costs related to the measure are anticipated to be minimal - See explanatory analysis.

Analysis:

SB 855 - 3 provides that professional licensing boards should study how immigrants and refugees are authorized to practice a profession regulated by the board. Boards are directed to adopt methods to reduce barriers to licensing and certification for immigrants and refugees. Professional licensing boards are directed to report to the Legislature on their progress in meeting the requirements of this bill no later than November 30, 2019.

There is likely to be a minimal fiscal impact related to this bill for most of the affected boards. Each board has a different licensing process and implementation of this measure could require boards to change licensing processes. These potential costs will not be clear until after boards have assessed their licensing practices in regard to immigrants and refugees.
