Subject: Opposition to proposed HB2020- Cap and Trade

Oregon's House Bill 2020, Cap and Trade, is going to affect the climate alright – the economic climate of every man, woman, and child in Oregon. This bill will also affect every square foot of our land, intended to par away only a miniscule percent of greenhouse gases. Oregon in #38 of our 50 states for carbon emissions.

The legislation will cause decimating harm to everyone in the State, especially rural Oregon, because we have less opportunities than larger areas for business to replace those companies that can, and will, leave Oregon taking with them jobs and revenue so vital to our struggling economics. In rural counties a hundred jobs is the equivalent of 1000 jobs in the I-5 corridor or the Portland area. We need every job and every worker we can find.

Our vital industries in Eastern Oregon depend on the trucking industry for shipping our products out for sale to other markets or to bring in goods to our citizens for our needs. All this will put our producers and our citizens at a great disadvantage and may lose markets due to our higher prices.

HB2020 focuses on reduction of fossil fuel use (i.e. clean energy), but does not take into account the other factors that naturally lead to a reduction in carbon (carbon stores) such as our forests. Restoring the health of our forests and reducing wildfire recurrence should be the primary consideration over simply reducing fossil fuel consumption.

Losing jobs and raising all our costs of living for our citizens at the same time, is beyond realistic. It is cruel and unfair. No amount of subsidies or give-away programs will ever equal what this bill takes away from our citizens for the next 30 years of our lives.

Something so divisive should never be left up to such a few number of people, but should only be up to vote of the people of the State. We the people should be free to choose what is best for our families and ourselves, we need jobs for our communities to survive and a cost of living that we can afford.
