RE: 19-21 bonds for the Integrated Eligibility ONE system project testimony

Dear Co-Chairpersons:

DHS requests bonds to support the continuation of the ONE Integrated Eligibility & Medicaid Eligibility (ONE IE & ME) Project. The ONE system will be a single eligibility determination system for Non-MAGI Medicaid, Supplemental Nutrition Assistance Program, Temporary Assistance for Needy Families, and Employment Related Day Care programs. These resources would support DHS' business needs and is related to the Legacy System Project DHS is undertaking to ensure functionality not assumed into the Integrated ONE system from legacy systems remains available for DHS business usage.

Due to changes in schedule, an additional \$4.7 million in bonds is necessary for the full funding of the project for a total request of new bonds in 19-21 of \$37,500,000, which will also incur \$665,000 for cost of issuance and new debt service in 19-21 of \$5,757,349 above the amount for prior sales which is in the base budget. While this increases bond need, there is a net decrease in the overall need for GF of \$1.3 million due to less Maintenance and Operation costs anticipated in 19-21 due to a 4-month extension of the project timeline offset in part by an increase in debt service. This extension was deemed necessary to ensure the quality of the project is not sacrificed due to unrealistic internal time lines for a project this size and scope. Of the revised ask of \$22.67 million, \$17.78 or 78% of the request is Medicaid federal funds. The total fund revised ask for 2019-21 is \$214.1 million of which \$141.4 million or 66% is federal funds.

The table below overviews the change in estimated funding for the project in 2019-21 from Governor's Budget to current state.

The OHA additional other funds limitation is for OIS related services shared with OHA but will be funded by DHS.
