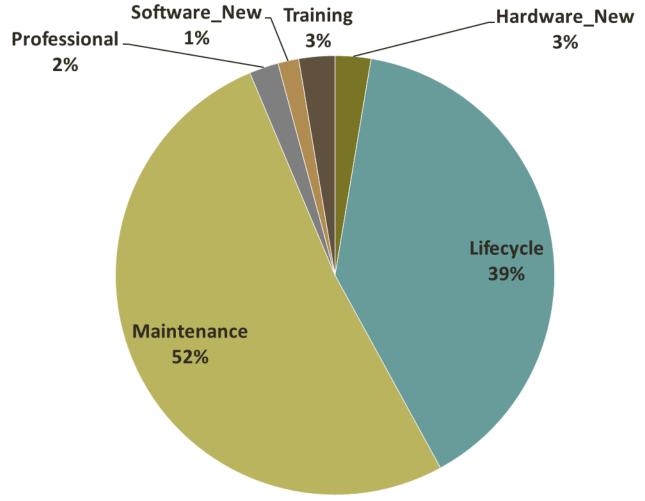

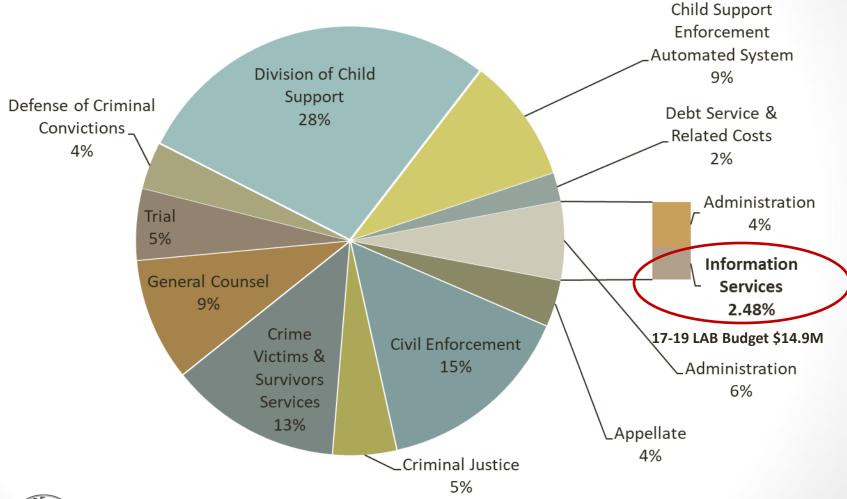


POP #104 – Essential Costs for IT by Category



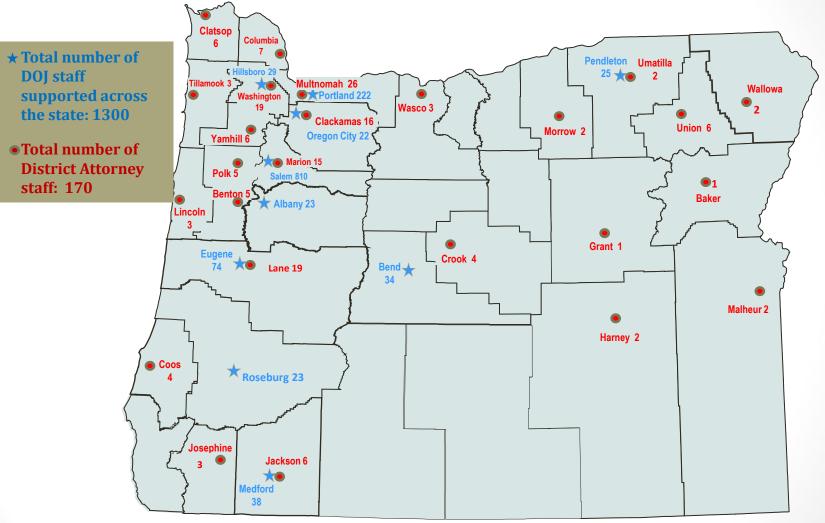


DOJ Budget - IT Percentage



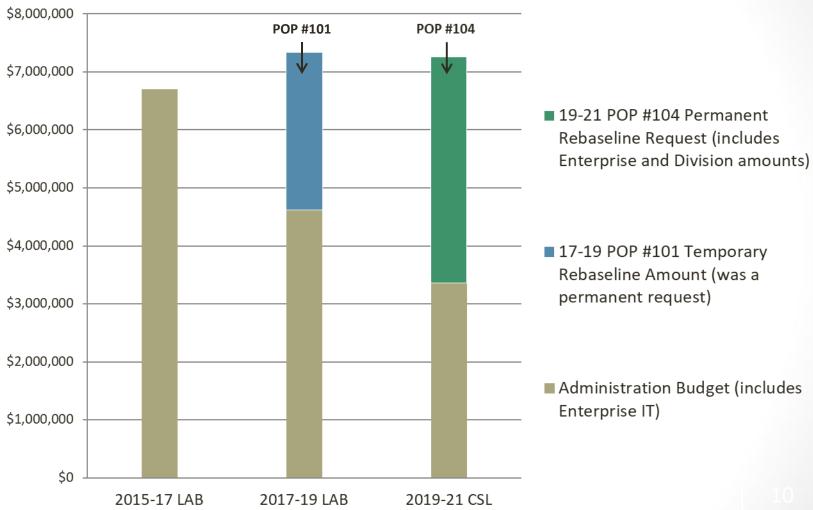

POP #150 – Renew HB 2101 Sunshine Committee Staff

Continue a Legislative Initiative.

Continue the important public records work of the Sunshine Committee as initiated by the 2017 Legislature in HB 2101, which established a 15-member Oregon Sunshine Committee staffed by the Department of Justice. Due to the duration of work anticipated, DOJ requests that the original two .50 FTE temporary (LD) staff positions be made permanent.

POP #151 – Defend Oregon Statutes

Benefits Oregonians by pursing legal actions in defense of Oregon state statutes and the Oregon Constitution.

These cases involve issues of immigration, funding for the Affordable Care Act, Oregon's status as a Sanctuary State, and rescission of the Deferred Action for Childhood Arrivals (DACA) program. There could be other actions in the future that Oregon must initiate or join in order to protect Oregonians.

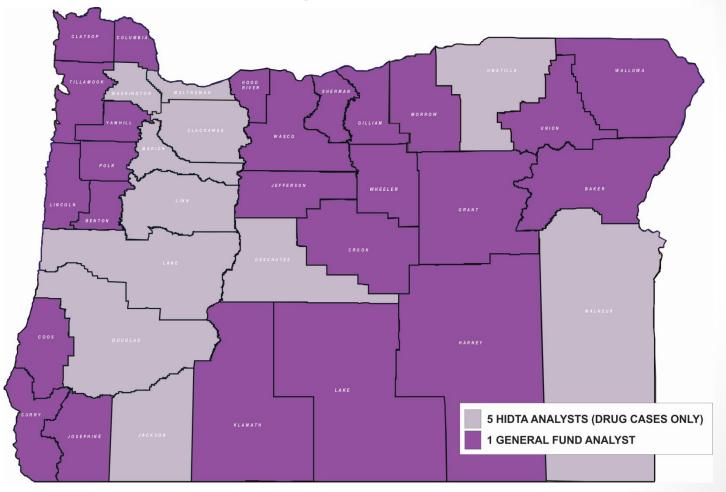

ODOT anticipates our average caseload will increase 200% over the next 1-3 years (from 50 cases/year to 150 cases/year).

NEW Package – Water Resources Department Legal Services

Defending Oregon Water Resources Department (OWRD) decisions related to regulation of water rights.

- Regulation of junior water rights to meet the rights of senior water right holders.
- Regulation of water users using water without a water right.
- Regulation of use that is inconsistent with the conditions and limitations contained in a water right.

NEW PKG - Defense of Criminal Convictions/ Trial Division Mandated Caseload Revision

Preserving convictions and sentences obtained by the state's prosecutors.

Main factors driving increased workload:

- Increased scrutiny of Post Conviction Relief (PCR) claims by the Oregon trial and appellate courts.
- Increase in the number of PCR claims and length of petitions.
- Increase in the use of expert witnesses.
- Increase in length of trial memoranda.
- Average hours worked per PCR case has increased from 43.79 to 57.04 in the last 18 months.

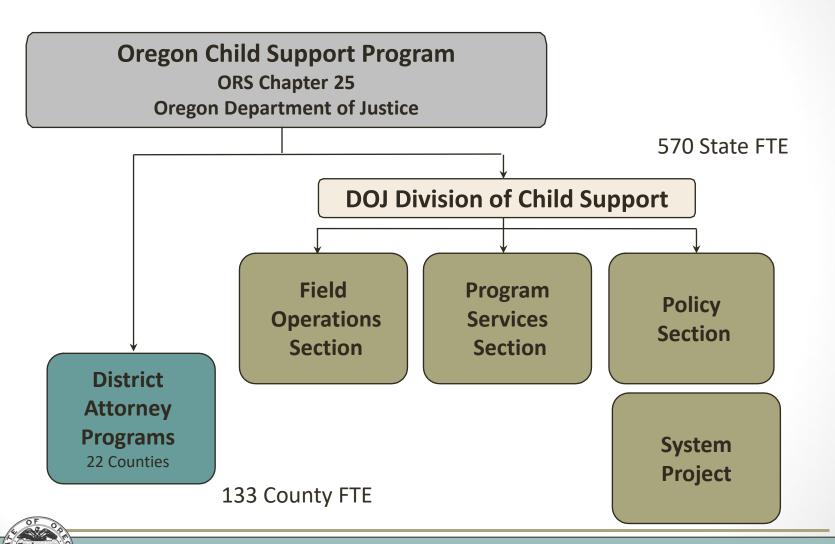

POP #450 - Revenue Restoration

Diminishing Funding Stream – Other Funds

Ongoing loss of recoveries resulted in 070 – Revenue Reduction

DOJ Division of Child Support collects TANF recoveries as revenue to help fund operations expenses (Other Funds)

But the nature of child support programs – and their funding – has been changing over several biennia, and will continue to do so

- TANF caseloads diminishing both nationally and in Oregon
- State-assigned TANF recoveries continue to decline due to law changes related to TANF
- Increase in percentage of collections going to Oregon families due to evidence-based changes in state law and policy

Reduction in Other Funds operating revenue results in related loss of matching federal funding.

• \$6.2 million reduction in recoveries + \$11.6 million related reduction in federal match = **total reduction of \$17.8 million**



POP #450 - Revenue Restoration

This request substitutes General Fund for the lack of Other Funds revenues required for the state share (1/3) of the operating budget

\$6.2 M GF enables \$11.6 FF match = \$17.8 M in total funding

91.44 FTE (92 positions)

16% of the Division's personnel

- Impacts to funding and performance also impact 22 DA offices
- Greatest impacts to Program federal performance measures 12-18 months following staffing reduction
- Failing federal performance requirements results in:
 - Penalties and reduced incentive funds to Child Support Program
 - Direct reduction in the state TANF grant

Origin Operations & Maintenance

 - Same staff embedded with implementation contractor (Deloitte) throughout the design, development, implementation of Origin
- Leverage current management structure
 - No new management positions
- Meets Origin operational system support needs in house without augmenting with contracted system support services

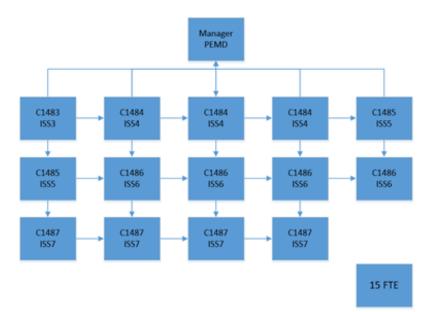

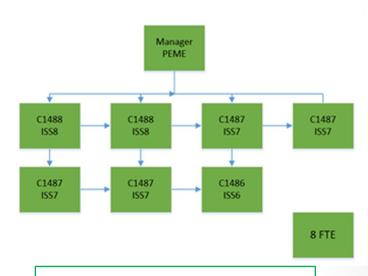

System Project FTE

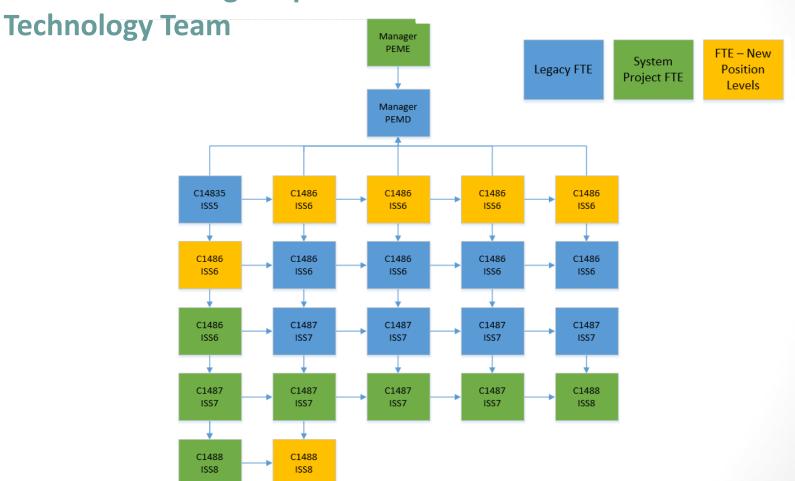
Origin Project Technology Positions

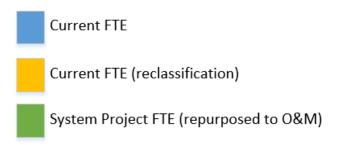

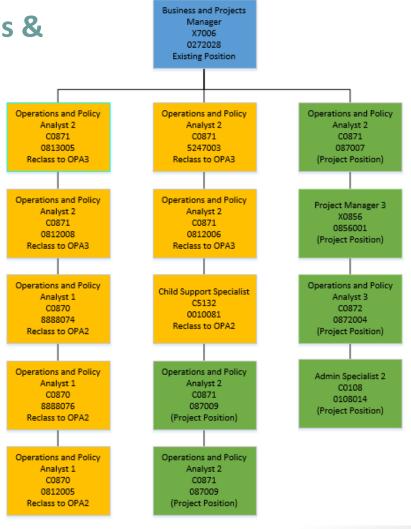

Origin Operations & Maintenance

Without this package, vendor support would be necessary to operate Origin to maintain functionality of the Oregon Child Support Program.

Estimated cost for vendor (Deloitte): **\$13.4 million** in addition to the contracted costs for finishing the system project.

POP #475 – System Project

New Child Support System – Origin

All states must maintain a child support automated system that meets federal certification requirements.

- Oregon's former system (CSEAS) was one of the oldest systems in the nation, using components and databases from the 1970s
- The Program has worked with its federal oversight office on a multiyear, prescribed process to replace its certified system
- POP 475 allows the Program to complete the last phases of the project: federal certification, post-implementation technical knowledge transfer, and operationalization
- This package also includes debt service for the last series of bonds sold in February 2019

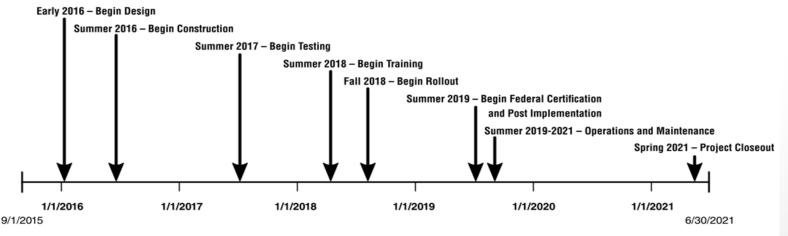

- Although eventual migration to the State Data Center is planned, it does not have the capacity and technology to support this system.

- Increase in number of counties in which DOJ Division of Child Support handles the entire caseload
 - Klamath, Josephine, Benton, Wasco county programs returned to the state
 - Non-assistance caseload typically has more legal actions in circuit court
- Increase in civil contempt efforts, resulting in significantly larger collections for families

POP #300 - Victims of Crime Act Budget

Supporting Crime Victims and Survivors.

Since 2016, funding for the Victims of Crime Act (VOCA) has continued to increase. The VOCA Assistance award is sub-granted through the Division to non-profit and prosecutor-based victim service providers as well as child abuse intervention centers.

POP #250 Ongoing Grants (UASI & SHSP)

Investigating Complex Crimes.

- Urban Area Security Initiative (UASI) grant is designed to assist high-threatened and high density urban areas.

- Both federally funded through the Oregon Office of Emergency Management/Military.

POP #453 - Federal Fee Change

Implementing a Federal Law change.

- The federal Bipartisan Budget Act of 2018 increased the annual collection fee for Child Support Programs from \$25 to \$35.
- The law also revises from \$500 to \$550 the amount that the State must collect and disburse to the family before imposing the collection fee each year.

Changes to budgeted positions to realign them with actual business needs and resolve work out of class and other budgetary matters.

- Adjusts 9 positions in the Administration Division.
- Adjusts 4 positions in the Trial Division.
- Adjusts 5 positions in the Civil Enforcement Division.
- Moves 3 positions from the Civil Enforcement Division to the Administration Division.
- Moves 4 positions in the Civil Enforcement Division across programs.
- Moves 1 position in the Criminal Justice Division across programs and changes funding split.

- Administration Division expenses are funded by assessing the other DOJ divisions a share of the costs.
- Allocations are determined using a model reviewed and approved by the federal government.
- DOJ budget does not match the federally approved charges.
- Without this funding, other budgets must be used to fill this gap.

Legal Fund



DOJ's statutory billing authority

- 180.160 Charges for services to public agencies; rules.
 - Provides that DOJ may charge agencies and other public bodies for rendering legal assistance.
- 180.170 Billing for services to public agencies.
 - Provides that DOJ shall estimate biennial expenses in advance and invoice agencies and other public bodies for their share of these expenses. Provides for adjusting future invoices for prior differences between actual and estimated expenses.
- The hourly billing rate is not set in statute. It is developed in conjunction with the development of the biennial budget.
 - The rate is not final until the end-of-session omnibus budget bill.



What is the Legal Fund?

The Legal Fund is an internal service fund which records the revenues and expenses for providing Legal Services to state government.

– each with a user fee.

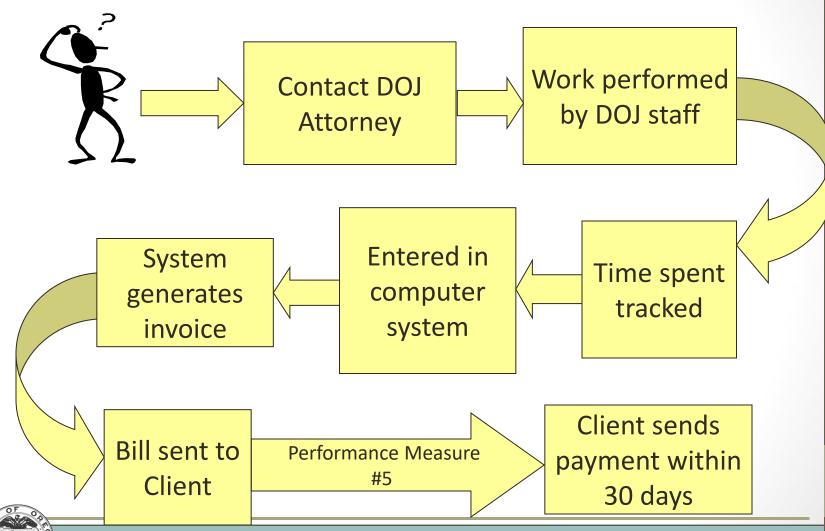


Legal Fund Budget Model:

- Other Funds expenditure limitation to hire employees and pay operating costs.
- The legal rate billed to client agencies has to be adequate to fund:
 - The attorney
 - Contribute to division operating costs for supplies, services, technology, capital items and costs charged to divisions for rent, payroll, accounting, human resources, etc.
 - Ideally, billed revenue should equal actual expenses.

Legal Rate – Two Components

Direct Cost of the Hours of Work

Plus

Operating Costs and Assessments for Agency & State Overhead *

* - Overhead includes non-billable hours, division operating costs, administrative assessments the department receives for technology, telecommunications, rent, insurance, accounting and human resources.

Calculation of the Legal Rate

Total projected biennial legal service costs

Rate * =

Projected number of biennial billable hours

* - Rate is actually assigned in the end-of-session omnibus budget bill.



Legal Rate Parallels the State Budget Process

- Agency Request Budget Legal Rate is an estimate of the ARB with all budgetary requests made by the Department of Justice.
- \$223 / Hour

 Governor's Budget – Legal Rate recalculated to represent Current Service Level plus adopted Policy Option Packages and other components of Governor's Budget.

\$208 / Hour

 Legislatively Adopted Budget — Legal Rate recalculated for each legislative budget decision affecting Department of Justice.

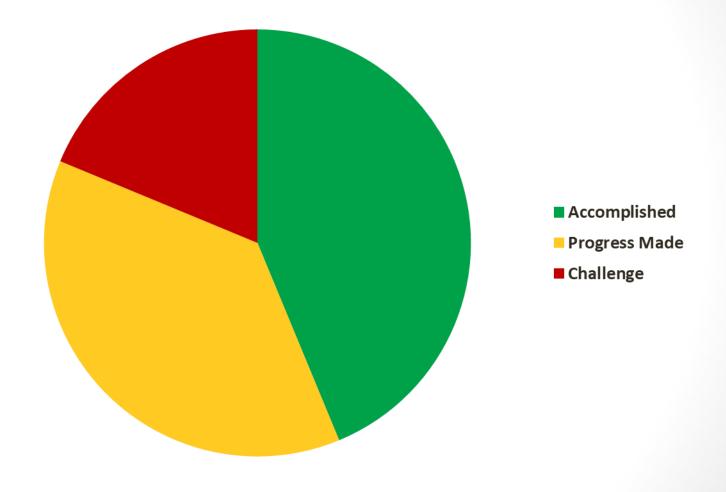

- 1 % of legal cases in which the state's position is upheld.
- 2 % of appropriate litigation resolved through settlement.
- **3** Amount of monies recovered for the state divided by the cost of recovery.
- **4** Average time from receipt of contracting document to first substantive response to agency.
- **5** Percent of legal billing receivables collected within 30 days.
- **6** % of timely and complete charities' reports submitted relative to total charities registered.
- **7** % of customers rating agency's customer service as "good" or "excellent"; overall customer service.
- **8** % of Criminal Justice Division cases resolved successfully.
- **9** % of crime victims compensation orders issued within 90 days of receipt.
- 10 % of support collected by the Child Support Program (CSP), which is distributed to families.
- 11 % of current child support collected relative to total child support owed.
- 12 % of CSP cases paying towards arrears relative to total CSP cases with arrears due.
- 13 % of CSP cases with support orders relative to total CSP cases.
- 14 % of adult victims leaving Domestic Violence shelters with a safety plan after a stay of five days or more.
- 15 % of sexual assault exams conducted by specially trained Sexual Assault Nurse Examiners (SANE).
- 16 % of Defense of Criminal Convictions (DCC) cases briefed within 210 days.



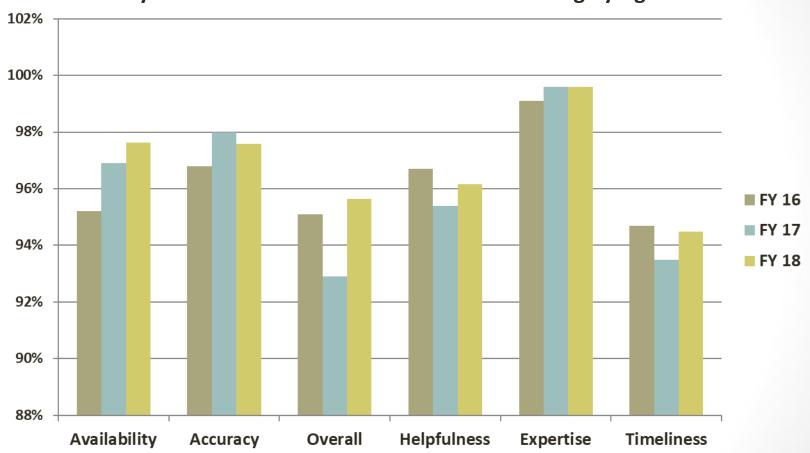
