Abandoned and Derelict Vessels

- * ORS 830.908 defines an abandoned boat as:
- "a vessel that has been left without authorization on public or private land, the waters of this state, or any other water."
- * ORS 830.908 defines a derelict vessel as:
- "(a) Sunk or in imminent danger of sinking;
 - (b) Obstructing a waterway;
 - (c) Endangering life or property; or
- (d) In such dilapidated condition that it is in danger of becoming a significant environmental hazard as evidenced by repeated and documented instances of leaking fuel, sewage or other pollutants."




Number of ADVs 2005-2019

Additional Environmental Concerns



Cost

Cost varies but increases significantly if vessel sinks:

Average cost afloat recreational ADVs = \$3,200

Average cost sunken recreational ADVs = \$5,000

Commercial vessel costs is too difficult to know, but is significantly higher than recreational

Current Funding:

OSMB: \$150,000 per biennium

DSL: \$35,000 per biennium

Staff time, resources, DOJ fees, Sheriff costs, etc. all add up

Prevention and Awareness

- * Key to ADV's to minimize impacts to environment, the public and reduce the financial impact.
- * Coordination between agencies, states, ports, marina owners, and other private partners
- * Get the public involved and gather support



Efforts to Date

- * Derelict Vessel Task Force
 - Tracking and Inventory
 - * Agency Coordination
- Transient Boat Work Group
 - Engage/educate boat owners
 - Working with non-profit for alternative housing
 - Vessel Turn in program
- * Derelict and Abandoned Commercial Vessel Task Force
 - * Work with marinas and ports
 - * Research funding and preventative strategies
- * Pacific States/B.C. Oil Spill Task Force
 - * Focus on blue ribbon model program

Next Steps

- * Issue is not going away
- Issue does not belong to one agency
- * DEQ, OSMB, and DSL are all on a regional work group to help create a blue ribbon model ADV program
- * Funding is needed to address this issue
- * Legislative direction may be necessary in the future
