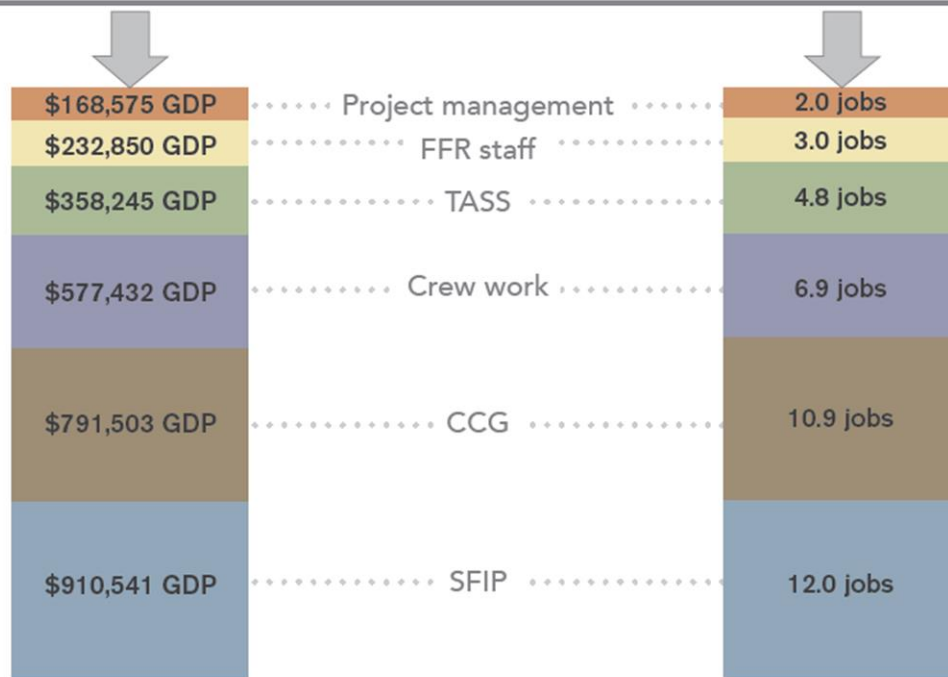

- Tool
- Implementation
 - Treatments
 - Data collection and planning
- Restoration
- Funded with federal \$
- Uses state procurement

GNA is not...

- Program with dedicated funding
- Handoff of Decision authority
- Relief to fulfill federal environmental laws
- Restricted to forest management

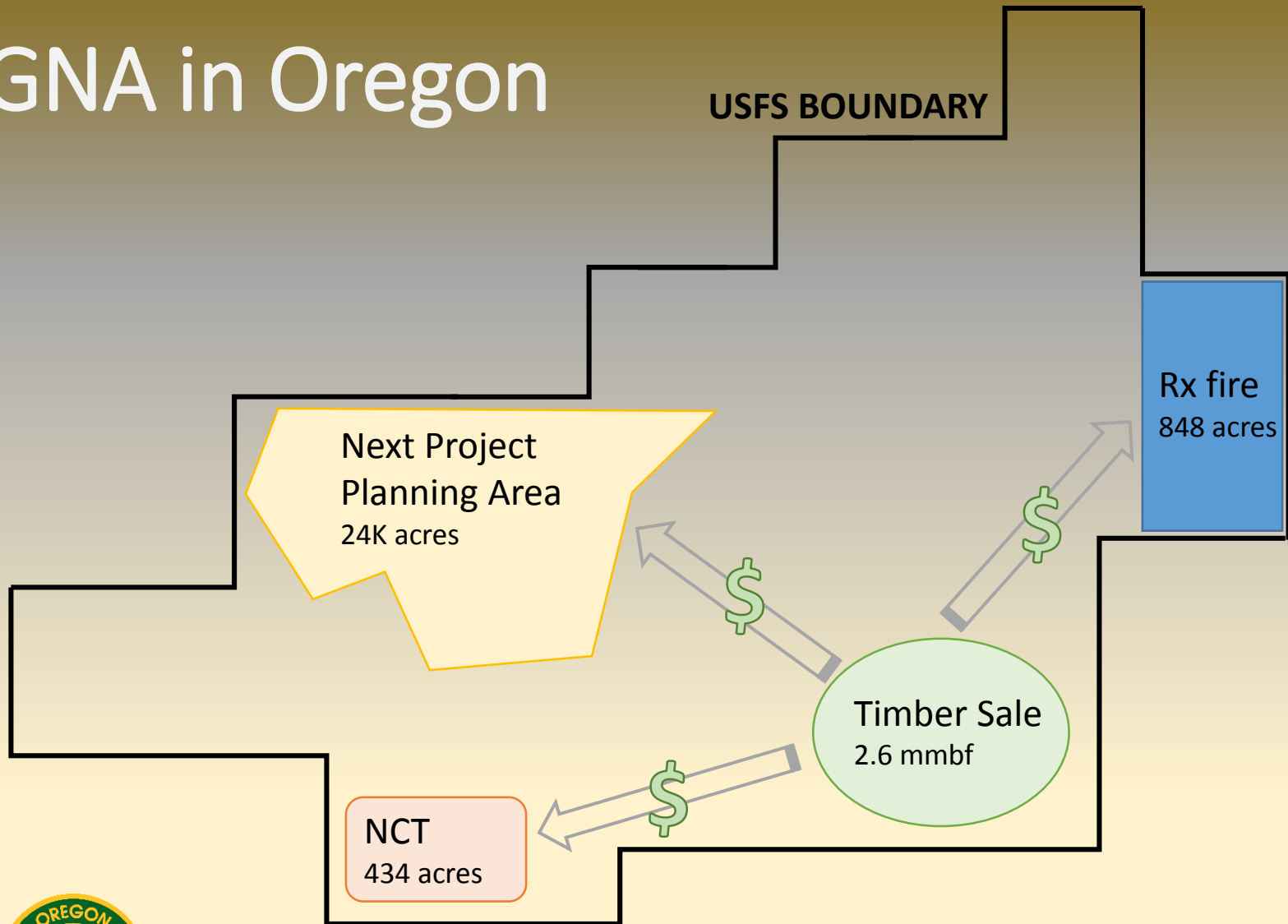

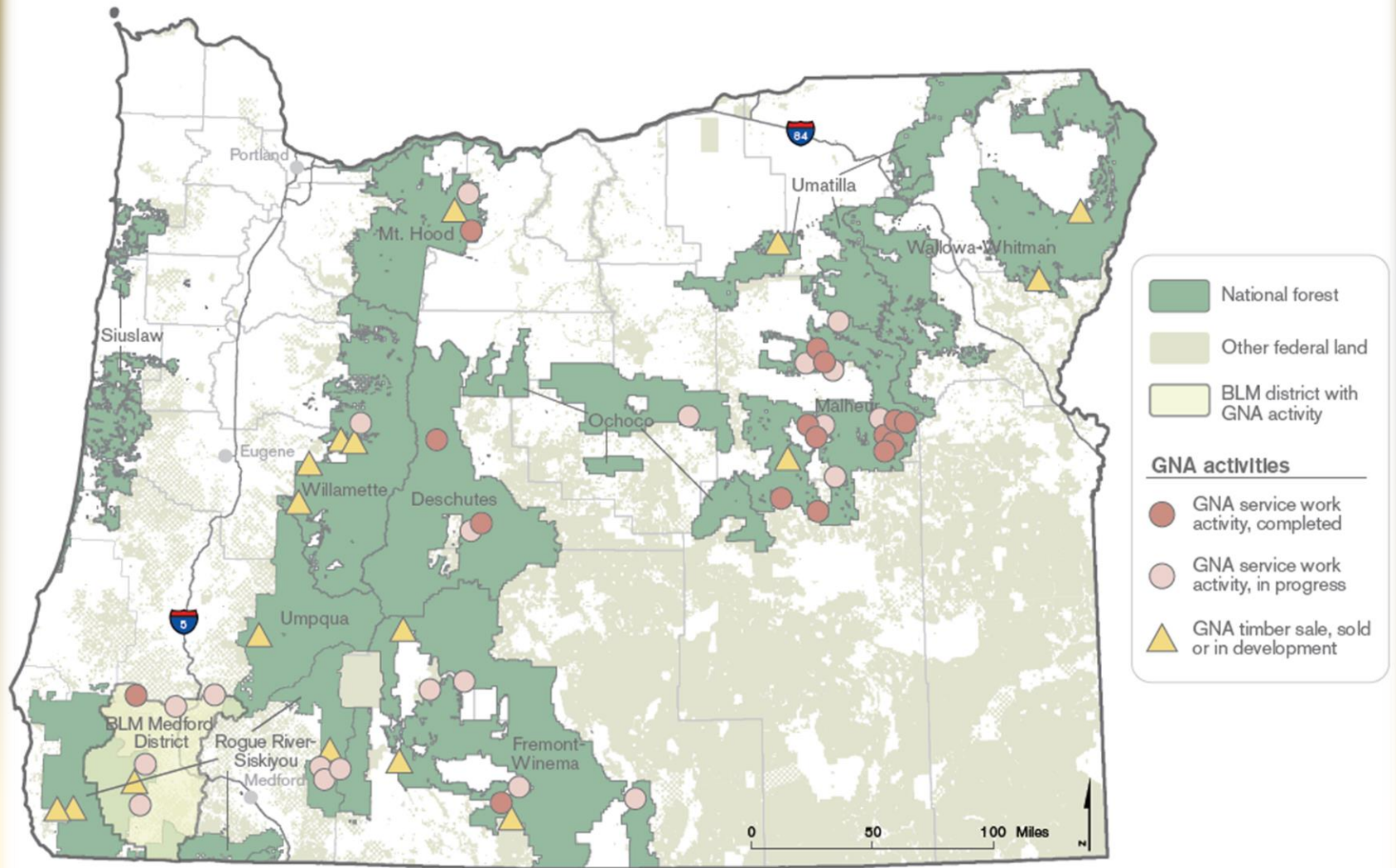
- \$3M in agreements
- 16 completed activities, 21 in progress
 - 5,221 acres of sale prep complete
 - 1,081 acres of fuel reduction completed

Product Removal

- \$2M in agreements
- SOLD:
 - 3 timber sales
 - 5 mmbf
- 5 other sales to be sold by July 2019
- By FY 2020 → 30 mmbf

The Next Frontier: Project Planning

- National Environmental Policy Act (NEPA)
- Categorical Exclusions (CEs)
 - 2014 Farm Bill: 3000 acres for Insects & Disease
- House Bill 4118 (2018) pilot projects
 - Miller Lake: Fremont-Winema NF, 3000 acres
 - Swamp Creek: Umpqua NF, 70 acres
 - Catherine Creek: Wallowa-Whitman NF, 70 acres
- Goal: to contract planning on 5,000 acres per year
