I enthusiastically support Gov. Kate Browns \$12M capital investment request for a statewide multi-hazards alerting system for earthquakes and wildfires.

ShakeAlert will provide seconds to minutes of warning of impending ground shaking, allowing organizations to carry out pre-determined actions for safety and, through automation, industry, utilities, and transportation sectors will be able to power down or protect critical operations. It could have an important life/safety impact in our County by closing critical valves, prevent toxic fumes from release at Tillamook Creamery, opening fire station bay doors-allowing access to critical response equipment, shutting off water valves allowing municipalities to preserve their critical water resource and much more!

By investing in sensors for the ShakeAlert earthquake early warning, cameras for ALERT/Wildfire, and telemetry to allow real-time communication, the state will be advancing a multi-hazard approach to disaster response and mitigation.
